

AIRTEL SUPER SINGER SEASON 5: VOTING ACTIVITY (POLL)' RULES

Rules for the Voting Activity to determine winner/s of AIRTEL SUPER SINGER SEASON 5 telecast by Vijay Television Private Limited (VTPL):

1. The Poll shall commence from 9th March 2016 at 21.30 hours and would be open till 19th March, 2016 1:00 hours or until the completion of the Live telecast of the entire performance of all contestants competing in the Grand Finale of Airtel Super Singer Season 5, whichever is earlier (Poll Period).

2. During the Poll Period, the Channel shall at its discretion telecast the performance of the contestants selected for competing in the Grand Finale of "Airtel Super Singer Season 5" scheduled on the 18th of March 2016 at Chennai ("Program") everyday from 9th March, 2016 between 21:30 hours to 22:30 hours (Saturday & Sunday excluded) and repeats of each such episode as per its program scheduling policy. Vijay Television Private Limited ("VTPL") and/or the Channel reserves the right to change the dates, the timings and days of the Program, without giving prior written intimation to the viewers.

3. The viewers by participating in the Poll shall get an opportunity to cast their vote in favour of any contestant(s) named in Rule 4 and competing in the Program.

4. The voting ID of the contestant is as follows:

5. A viewer interested in casting his/her vote for a favorite contestant shall follow the steps stated herein below:

- Log on to the website www.supersinger.in;
- Notify your email id as required in the website;
- Click on the link sent to your notified email id and vote for your favorite contestant through the link;

6. During the Poll Period, the Viewers shall not be permitted to vote between 18:00:00 hours to 21:29:59 hours as per IST on all days other than the day of the Grand Finale on which day, the viewers shall be restricted from voting between 16:00:00 hours to 18:00:00 hours IST (“Non-Poll Hours”).
7. A Viewer shall be entitled to only 5 votes per email id per day.
8. Vote(s) cast during (a) Non-Poll Hours or (b) prior to or later than Poll Period mentioned herein and (c) beyond the permitted number per email id shall not be considered and shall be null and void.
9. VTPL / its authorized process validator shall be entitled to reject votes cast by email ids generated by any automated process or by such other process which in the opinion of VTPL/its authorized process validator is dubious.
10. The votes received from the viewer(s), and the scores obtained by the respective contestant from the judges in the Program, shall be ranked separately.
11. The ranks secured, as per the Poll votes and the scores obtained from the Judges, shall have equal weightage (i.e: 50% weightage to the rank based on votes and 50% weightage to the rank based on scores obtained from Judges). The winner of Airtel Super Singer Season 5 shall be decided based on the cumulative weighted average ranks secured by the contestant(s) through the Poll and the scores given by the judges for their performances in the Program. In case there is a tie in the rank determined by the cumulative weighted average method mentioned herein, then such tie shall be broken by a special Jury comprising of 3 judges as may be constituted by VTPL for this purpose.
12. VTPL, for reasons it deems fit and appropriate including but not limited to technological failures or breakdowns, may cancel the Poll activity and the Poll Period shall automatically end upon such cancellation. Votes received, if any, till such time of cancellation shall only be considered and the remaining shall be deemed votes cast later than the Poll Period. The decision of VTPL with regard to such cancellation shall be final and binding.
13. It is expressly stated that this is simply a Poll to enable the viewers to choose their favorite contestant(s). There shall be no prizes or gifts for participating in the Poll.

PART B- GENERAL RULES

1. VTPL or the Channel reserves all rights to make amendments to the existing rules without prior notice.
2. By participating in and accepting the Terms & Conditions of this poll, the Voter confirms that he/she is above the age of 18 years and also confirms that he/she is neither an employee of VTPL nor is engaged by VTPL for any purpose in connection with the Program.
3. The voter(s) of the Poll agree that he/she shall hold harmless the Channel, VTPL, its employees, officers or any other person in relation to any injury/damage/harm/loss suffered by him/her, in any manner, whatsoever in connection with the Poll and shall also not file in person/ through any family

member and/or third party any applications, criminal and/or civil proceedings in any courts or forum against the sponsor and/or the Channel and/or VTPL to claim any damages or relief's arising on account of the Poll and/or the votes cast by the voter and/or due to anything connected to the Program.

5. The participation of the viewer(s) in the Poll shall mean that the viewer (s) has read, understood, accepted and agrees to abide with all the rules including the general rules of the Poll.

6. The decision of the Channel and/or VTPL with regard to the outcome of the Poll shall be final and binding and in no event shall the viewer/voter dispute the decision made by VTPL, Channels and/or its employees in connection to the Poll.

7. The terms of this rules and regulations shall be construed in accordance with the laws of India and incase of any dispute or other matter arising in reference to the Poll shall be referred to a sole arbitrator appointed by VTPL and shall be governed by the Arbitration and Conciliation Act, 1996, amended from time to time. The venue for arbitration shall be Mumbai, in English language. The costs, charges and expenses in connection to arbitration shall be solely borne by the viewer(s) disputing. The arbitrator's award shall be final and binding on the parties to the dispute.
