TERMS AND CONDITIONS FOR "Furious7OnPIX CONTEST"

A. ACCEPTANCE OF TERMS AND CONDITIONS

You acknowledge and agree that the following Terms of Use constitute a legally binding agreement (hereinafter the "<u>Agreement</u>") between you (hereinafter the "<u>User</u>" and/or "<u>You</u>") and Sony Pictures Networks India Private Limited ("<u>SPN</u>"). You represent and warrant to SPN that you have read and understood the Terms and Conditions and the Privacy Policy (together the "<u>Terms</u>"), and agree to abide by the Terms and that you have the legal capacity to enter into this Agreement.

- 4. does not harm minors in any way;
- 5. does not infringe any patent, trademark, copyright or other proprietary rights;
