

TERMS AND CONDITIONS – BSNL GOLD CLUB CONTEST

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS CONTEST KNOWN AS “**BSNL GOLD CLUB CONTEST**”. BY PROCEEDING WITH PLAYING THE **BSNL GOLD CLUB CONTEST**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**Terms and Conditions**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE **BSNL GOLD CLUB CONTEST**.

Terms and Conditions:

1. “**BSNL GOLD CLUB CONTEST**” (hereinafter referred to as the “**Contest**”) is conceptualized, organized and conducted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India (“**OnMobile**” or “**Organizer**”) for active¹ pre-paid and post-paid category of Subscribers² (“**Subscriber(s)**”) of Bharat Sanchar Nigam Limited a company having its registered office at Bharat Sanchar Nigam Limited, (NS Branch), 10th Floor West Wing, Chandralok Building, Janpath, New Delhi - 110001 (hereinafter referred to as “**BSNL Mobile**”) and is valid during the period from **June 15th 2015, 00:00:01 hrs to 15th June 2017, 23:59:59 hrs**, both days inclusive, Organizer reserves the right to extend or shorten the Contest Period, as it deems fit, and any such change shall be published on the website, www.bsnl.contestzone.in (“**Website**”). The Terms and Conditions can be amended or varied from time to time or withdrawn and therefore, please visit the Website to keep Yourself (defined below) updated and informed.
2. The Contest is open for all Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below, who belong to the following BSNL Mobile telecom circles (“**Circles**”) of KERALA, KARNATAKA, ANDHRA PRADESH, TAMIL NADU\CHENNAI, CHANDIGARH (HARYANA, HIMACHAL PRADESH, PUNJAB, JAMMU & KASHMIR), RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, PUNE, MADHYA PRADESH & CHATTISGARH, GUJARAT, KOLKATA, WEST BENGAL, ASSAM, NORTH EAST), ORISSA, RANCHI by following the subscription process mentioned hereunder.

¹ An active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in the Contest or any other contests offered by the Organizer and BSNL Mobile jointly.

² Subscriber shall mean the rightful user of a BSNL Mobile connection, pre-paid or post-paid, in whose name the mobile phone number (MSISDN) is registered with the operator. In the event the number / connection is registered in the name of a company or firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Contest, receive the prizes and accept the terms applicable for the Contest.

3. Eligibility

This Contest is open for subscription for all active prepaid and post-paid categories of BSNL Mobile Subscribers who fulfil the following criteria:

- Subscriber must be of or above 18 years of age;
- Subscriber must be a resident of India;

- For Prepaid Subscribers – Subscribers must have a minimum requisite balance of Rs. 7 to be able to subscribe to the Contest during the Contest Period.

For the purposes of these Terms and Conditions, wherever the context so requires “**You**” or “**Your**” shall mean any natural person who is a BSNL Subscriber. Also, by participating in this Contest, You:

- Agree to the Terms and Conditions mentioned below and give Your consent for the same;
- Agree that You are entering into this Contest as an independent party and nothing herein establishes an employer-employee relationship between You and BSNL Mobile or between You and OnMobile and You are acting voluntarily, using Your own time and resources to participate in this Contest, solely at Your own risk;
- Warrant that You have read, understood and agreed to conform to these Terms and Conditions;
- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and
- Warrant that prior to participating in the Contest, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.

The Contest will be available in the below mentioned languages:

Hindi, English, Kannada, Telugu, Malayalam, Tamil, Marathi, Gujrati, Punjabi, Bengali, Oriya, Assamese.

A Subscriber by participating in the Contest, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the Winners (defined later) under this Contest as set out herein, and any appropriate changes that may be made to this Contest by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever.

Subscribers who are roaming outside their home Circle will be barred from subscribing and playing the Contest.

Further, the Subscribers who participate in the Contest and are chosen as Winners under each category of prize in accordance with the Winner selection process detailed in these Terms and Conditions will be the registered BSNL Mobile Subscribers of the winning mobile phone number and not merely the players using such mobile number (“**Winner(s)**”). If the Winner is not able to provide sufficient evidence to show that he/she is the Subscriber of the mobile number, the Organizer reserves the right to award the prize to the next eligible Winners or to forfeit the prize, at its sole discretion.

4. To Subscribe:

A Subscriber can subscribe to the Contest either by:

- Dialing the Unstructured Supplementary Service Data (“**USSD**”) String *505*66#
- Pressing 1 through Out Bound Dialer or In Bound Dialer followed by second consent.

If a Subscriber wants to unsubscribe from the Contest, then it can be done by calling the toll-free number 12555066.

5. Charging:

Once an MSISDN subscribes to the contest, the MSISDN will be charged Rs.7 every week for 7 minutes of usage. All Subscribers will be allowed to play the Contest only after being successfully charged Rs 7 every week for the Contest. If the charging is successful, such Subscriber will get a confirmation SMS on his/her number registered with BSNL Mobile along with the rules, prizes, Terms and Conditions URL, and the number on which she/he can call and participate in the Contest. The user can play the contest only for the duration of 7 minutes every week once they are successfully charged. If the charging is unsuccessful, the Subscriber will be sent an SMS on his/her number registered with BSNL Mobile, informing him/her of such unsuccessful charging.

6. Contest on Voice

- Contest will be available on the toll-free number 12555066 for all Subscribers.
- The questions under this Contest shall be based on general information available to the public at large.

- The Contest consists of a total of 120 questions, with 2 answer options for each question. The subscriber can only play 3 questions per week which he/she can play at any time during the week.
- The Subscriber can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer.
- After every question and answer options, a “beep” prompt will be played, post which Subscribers can answer the question.
- For every right answer the Subscriber will get 1 point. There is no negative marking for a wrong answer.

After every right or wrong answer, the Subscriber will be played an appropriate prompt followed by his/her updated score and the next question and option answers.

The time taken for answering a question is calculated from the time the question, answer and the “beep” prompts finish playing till the time the Subscriber provides an answer by pressing the relevant key.

- To listen to a question again Subscribers can press *.
- If a Subscriber stops playing the Contest after answering the nth question on any day during the Contest Period, then when he/she calls back on the toll-free number 12555066, he/she will be played the (n+1)th question. If a Subscriber stops playing the Contest without answering the nth question then when he/she calls back on the toll-free number 12555066, he/she will be played the nth question which may be different from what he/she received previously i.e., if a Subscriber listens to the 2nd question but drops the call without answering the 2nd question, then when he/she calls back, he/she will be played the 2nd question which may be different from what he/she received previously.

In the selection of any of the Prizes, in case of a tie in the score and in the time taken to answer, 1 round of tie-breaker will be conducted for all the tied MSISDNs. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

-Subject to Clauses 37 and 38 and the other terms contained herein, a Subscriber is eligible to win more than one prize during the Contest, which means that he/she can win more than one prize provided he/she meets the above conditions of the respective prizes.
