Terms and Conditions for "Ek Rishta Saajhedaari ka" Contest

The following terms and conditions ("T&Cs"/ "Terms and Conditions") shall be applicable to Sony Pictures Networks India Private Limited (Formerly known as Multi Screen Media Pvt.
