TERMS & CONDITIONS

1. Yeh Diwali Online Wali (the 'Scheme' where Subscribers can win Amazon.in Gift Cards of INR 5000) is organized and managed by Telenor (India) Communications Private Limited (Erstwhile Telewings Communications Services Private Limited) ('Telenor') having its registered office at Unit no. 902, 9th floor, Le Meridian, Commercial Tower, Windsor Place, New Delhi-110001.

The Scheme will be governed by these standard terms and conditions (collectively the "Terms"). Each Subscriber agrees that he/she has read and understood these Terms and by their participation in the Scheme and he/she agrees to be bound by the Terms.
