TERMS AND CONDITIONS

A. ABOUT THE CONTEST AND HOW TO PARTICIPATE

#LaLigaExperienceTripToSpain contest (herein after referred to as "<u>Contest</u>") is hosted by Sony Pictures Networks India Pvt. Ltd. and/or its affiliates ("<u>SPN</u>") in relation to the tournament La Liga ("<u>Tournament</u>") telecast on the channel Sony SIX and/or Sony SIX HD ("<u>Channel</u>") as per the terms and conditions stated hereunder ("<u>Terms and Conditions</u>"):

- 1. The Contest shall be hosted on the Facebook platform of the Channel viz. https://www.facebook.com/SonySixTV and the **Twitter** platform of the Channel https://twitter.com/SonySIX ("Platform"). The Contest shall be spread over a period commencing from November 4, 2016 until January 29, 2017 ("Contest Period"). During the Contest Period, SPN shall select relevant La Liga live matches (each SPN notified match will be hereinafter called as a "*Relevant Match*") during the Contest Period and will ask a question over the Channel during the live Match. Participants interested in participating in the Contest ("Participants") are required to provide correct answer / Entries to the question during the live transmission of the Notified Match ("Match Duration") and submit the same over either of the Platform using #LaLigaExperienceTripToSpain within the Match Duration. Participants are required to submit their entries during the Match Duration in accordance with the terms herein to make their participating entry a valid entry ("Entri(es)"). A Participant is free to submit as many Entries as he/she may like.
- 2. One (1) lucky winner shall be selected on a random selection basis after the Contest Period from a pool of Entries received during the Contest Period ("<u>Lucky Winner</u>"). Lucky Winner shall be notified within seven (7) working days or such period as may be notified by SPN upon end of the Contest Period. Lucky Winner stands a chance of winning LA LIGA EXPERIENCE ("<u>Prize</u>"). Prize shall mean to include roundtrip economic flight ticket from Mumbai/Delhi (origin flight shall be as per SPN's discretion) to Spain to watch a La Liga match, attending meet and greet event, accommodation for two (2) nights at hotel as per organiser's discretion, city tour, and internal transfers organized by SPN/La Liga.
- 3. In addition to one Lucky Winner, SPN shall select one (1) winner during each week of Contest Period providing correct answers / Entries during such week of Contest Period ("<u>Additional Winners</u>"). Additional Winners will be given merchandise relating to La Liga ("<u>Additional Winner Prize</u>"). Lucky Winner and Additional Winners are hereinafter collectively referred to as "<u>Winner(s)</u>".
- **4.** A Contest Participant stands chance of winning only once. Any subsequent wins (if declared) will be automatically void.
- 5. Within a period of twenty four (24) hours from the announcement of the Winner(s), the Winners will have to send a direct message to the Platform and/or such other contact address as may be notified by SPN with complete details including their Name, Telephone No, Postal Address, E-Mail Address & copy of Photo ID Proof (issued by Government authority) ("Contact Details"), failing which SPN may or may not select another Winner. In the event, successful contact with the winner is not established (i.e. in case the Winner fails to provide Contact Details to SPN on the Platform within twenty four (24) hours from the time of announcement of winner(s) for any reason whatsoever), that Winner shall not be considered for the Prize and SPN may/may not choose other Winner at its sole discretion.

6. Upon receiving the Contact Details within the above mentioned timeline, if any details are found missing or SPN requires any further information/clarification from the Winner to attempt and effectively coordinate the Prize delivery, SPN shall make a maximum of two attempts to contact the Winner within a span of twenty four (24) hours of receiving Contact Details to touch base with the Winner and attempt to coordinate the Prize delivery. However, in the event SPN fails to establish successful contact with Winner and/or is unable to coordinate the Prize delivery for any reason, SPN shall be not be responsible and/or liable to make any further attempts and/or provide any alternate Prize to the Winner.

7. Prize related conditions:

- mental injury and/or any other personal/professional loss or damage including loss of property while availing the Prize.
- x. SPN will not be held responsible if the Winner and/or his/her companion misses the flight, or for any loss/ damage to their person or property caused/incurred during transit or at any stage of availing or enjoying the Prize.

ADDITIONAL TERMS

- **8.** The Prize can be only availed at such time, date and/or venue as may be notified by SPN and no request for change of the same shall be entertained.
- **9.** Any and all taxes and/or levies applicable under the laws of India shall be borne by the Winner in relation to the Prize.
- **10.** Incomplete and/or Entries submitted after the Match Duration shall not be considered and shall be null and void.
- 11. SPN shall not be responsible for any technical disruption and/or failure/ server problems and/ or any other difficulties of such nature, due to which the participant is unable to participate in the Contest.
- **12.** SPN reserves the right to disqualify any participant from participating in the Contest without assigning any reason. The decision of SPN in this regard shall be final and binding upon the participants.
- **13.** The participants shall ensure that the Entri(es):
 - i. shall not violate the rights of any third party, including, but not limited to, privacy rights, copyrights, trademark rights and/or any other intellectual property rights; The participants shall indemnify the SPN, its officials, employees, representatives against any claim, loss, damages and liability arising as a result of infringement of third party intellectual property rights;
 - ii. is not harmful, harassing, blasphemous, defamatory, obscene, pedophilic, libelous, invasive of another's privacy, hateful, or racially, ethnically objectionable, disparaging, or otherwise unlawful in any manner whatever;
 - iii. does not harm minors in any way;
 - iv. does not violate any law for the time being in force;
 - v. does not deceive or mislead about the origin of such messages or communicates any information which is grossly offensive or menacing in nature;
 - vi. does not contain software viruses or any other computer code, files or programs designed to interrupt, destroy or limit the functionality of any computer resource;
 - vii. shall not create any liability for SPN or any of its respective parents, subsidiaries, affiliates, successors, assigns, employees, agents, directors, officers and shareholders.
- **14.** The Participant(s) represents and warrants that the Entries is an original work of the participant and the participant has all necessary rights, licenses, consents and permissions to

- use, and to authorize SPN to use, any and all copyrights, or other intellectual property rights in and to Entries in order for SPN to use the Entries on any of its platforms or otherwise.
- **15.** In the event of any discrepancy as to the date and/or the time of receipt of an Entri(es), SPN shall have the final decision in resolving such discrepancy.
- **16.** The Contest is open for residents of India only who access to the Platform page of the channel from Indian IP address. For purposes of clarity, an Indian resident accessing the Platform page of the Channel from a foreign IP address may not be able to participate.
- **17.** Non-resident Indians are not eligible for participation in the contest even if they participate by accessing to the Platform page of the Channel from Indian IP address.
- 18. This Contest is strictly governed by the laws of India including the Privacy Laws of India
- **19.** The participants must have attained the age of 18 years to participate in the Contest.
- **20.** Employees, agents and promoters (including their immediate family members) of SPN and any of their divisions, affiliates and subsidiaries, and others associated with the Contest in any manner, are not eligible to participate in the Contest.
- **21.** Participants shall ensure that all their Entries/response shall be in compliance to usage rules of Facebook depending on their chosen method for participation.
- **22.** To claim the Prize, the Winner must have valid proof of identity, age and address and/or any other document as may be required by SPN at its sole discretion;

SPN makes no representations and disclaims all express, implied, and statutory warranties of any kind to the Participant and/or any third party including, without limitation, warranties as to accuracy, timelines, completeness, merchantability, or fitness for any particular purpose.
- 35. Under no circumstance, unless due to willful misconduct or gross negligence, shall SPN and/or their directors, employees, officers, affiliates or subsidiaries, be liable to the Participant and/or any third party for any lost profits or lost opportunity, indirect, special, consequential, incidental, or punitive damages whatsoever. The Participant specifically agrees not to file in person/through any family member and/or any third party any applications, criminal and/or civil proceedings in any courts or forum in India against SPN and/or their directors, employees, officers, affiliates or subsidiaries to claim any damages or relief in connection with the Contest.
- **36.** By entering into the Contest, the Winner waive all copyrights, rights of publicity and any related rights and consents to SPN's right to picture, tape or portray him/her as a Contest Winner, and to exhibit this material in any and all media now existing or hereinafter created, including without limitation television, film, radio and print media, without any compensation whatsoever for advertising and publicity purposes, except where prohibited

- by law. The Prize Winner also consent to SPN's right to use his/her name, voice or picture, or the content of his/her Contest Entry(ies) (collectively, the "*Publicity Rights*").

- **42.** SPN reserves the right to change the Terms and Conditions of this Contest and to alter or terminate the Contest at any time.
- **43.** The decisions of SPN and its representatives shall be final and binding on all aspects of the Contest.
- **44.** The Contest shall be governed by and construed in accordance with the applicable laws in India. All matters with respect to the Contest are subject to the jurisdiction of the Courts at Mumbai only.
