

## **Terms and Conditions for #TrideviyaanOnSAB Contest**

The following terms and conditions (“T&Cs”/“Terms and Conditions”) shall be applicable to Sony Pictures Networks India Private Limited (“SPN”) owned television channel ‘SAB’ (“**Channel**”) contest relating to its show –Trideviyaan (“**Show**”) to be conducted on its Twitter and Facebook pages; by SPN and shall be termed as follows:

- **“#TrideviyaanOnSAB” Contest on Twitter and Facebook**

The above contest shall be referred to with its Contest title on the Twitter and Facebook pages which is owned by the Channel.

### **Contest “Basic T&Cs”:**

Following are the terms that shall be applicable to the Contest:

5. The Contest terms and conditions shall be mentioned on SPN website [www.sabtv.com](http://www.sabtv.com) (“Website”). The Participants agree that by participating in the Contest, the Participants shall be bound by the terms and conditions provided at the Website.
6. The Participants shall be required to provide basic personal information about them including but not limited to Participants name, address, telephone number or mobile number and email address in order to register and participate in the Contests. However, by participating in the contest, you agree to allow us authorized use of your information and agree to be bound by the “**Privacy Policy**” available on this Website.
7. The specific requirements for the Contest shall be outlined in the T&Cs of the contest.
8. For the Contest, each Participant must submit their complete Entry/Entries (as defined here below) in order to qualify as an entrant in the Contest through Specific Mode of Participation specified in Specific T&C’s stated at end of this T&C.
9. Participants entering the Contest may submit any number of Entries so long as such Entries meet SPN’s criteria as specified in these T&Cs even if not chosen as the final winners of the Contest and any Participant may at SPN’s sole discretion be declared a winner of the Contest.
10. The manner, day and the basis of choosing the winner (“Winners”) shall be specified in the T&Cs of the Contest.

11. The announcement about the Winners and the Prize (defined below) shall be as per the T&Cs of the Contest.
12. The distribution time and mode of distribution of the Prize shall be at the sole discretion of SPN.

21. SPN reserves its right to select and declare or not to declare the Winner in the Contest.

The Participant specifically agrees not to file in person/through any family member and/or any third party any applications, criminal and/or civil proceedings in any courts or forum in India against SPN their directors, employees, officers, affiliates or subsidiaries to claim any damages or relief in connection with the Contest.

In exercise of the powers conferred by clause (of) of sub-section (2) of section 87 read with section 43A of the Information Technology Act, 2000 (21 of 2000), the Central Government has framed the Information Technology (reasonable security practices and procedures and sensitive personal data or information) Rules, 2011("Privacy Rules") which makes it mandatory for any concern to deal with any personal information including sensitive personal information as per the said Privacy Rules.
