competition but they will be not considered for award. But, if short-listed, they wil
be felicitated with citation/certificate.
☐ Entry to competition free.
☐ Entrant must be over 18 years.
☐ Each photographer may submit up to five photos with detail as mentioned
below.
☐ By submitting the photograph for consideration, the photographer attests that:
☐Entry is an original photograph.
□S/he created the image and owns full copyright to pictures submitted.
☐Entrant is prepared to certify this attestation on request.
☐Submitted image has not been published in the past.
☐Submitted image has not been submitted in past any photo contests.
□S/he has obtained all necessary third-party releases.

	Submissions are in compliance with the legal and copyright laws of his/he country.
	If your photo(s) is shortlisted, you will be asked to re-submit it in high resolution (300 dpi on A3/A4 size paper). If deemed necessary, an entrant may also be requested to submit the original source files.

	with the rules by a technical panel of the Department of SSEPD.
	All entries passed by the screening panel will be submitted to a distinguish pane
	of experts in the issue and in photography to assess the conceptual and artistic
	depiction by the pictures of one, some or many ideas on disabilities.

The winning entry will be the most visually appealing, original and self-explanatory photo capturing the theme of "Persons with Disabilities at their Best" and shall be selected by an expert jury.
Pictures will be assessed for there:
Creativity and originality
Composition (technical excellence and quality)
Artistic merit (wow factor) and
Content (relevance)
Each picture will be assigned a score by the Expert panel and shortlisted for the final selection. The shortlisted images will go through a second round of scoring by a distinguished panel of judges, whose scores will be averaged to produce a final score. In all cases when there is a tie, the entry with the higher artistic merit score will be deemed the winner. The jury's decisions will be final and no correspondence will be accepted.

The Judges

An expert jury of eminent personalities, including renowned photojournalists and issue- experts, will select the best three photos. The judges will be drawn from the film, photography and disability fields. The names of the judges will be posted only after the closing of the contest.
