# RULES & REGULATIONS GOVERNING "AIRTEL PRASNA MAADI PADIVELU MEEDI" CONTEST IN "MEELO EVARU KOTEESWARUDU" – Season 4

### I. CONTEST DESCRIPTION:

"Airtel Prasna Maadi Padivelu Meedi" ("Contest", "APM") is a contest that will be held on the show "Meelo Evaru Koteeswarudu – Season 4" ("Show") solely for home viewers. The Show and Contest is telecast on Maa TV ("Channel") which is owned by Star India Private Limited and/or its affiliates (together known as "Company").

### **II. DEFINITIONS:**

- 1. "Participant (s)": Any person(s) who participates in the Contest and who (i) is above eighteen (18) years of age on date of participation in the Contest; (ii) is a citizen of India and residing in India and (iii) enters the Contest in accordance with the rules stated below. Employees of the Company, of the Producer, of the advertising agency which has been appointed from time to time, and also employees of the main sponsors; and members of their immediate family; persons other than Indian nationals, or Indian nationals living out of India, or those who do not qualify under the definition of resident of India as per the Income Tax Act, 1961 or those not conversant in spoken Telugu, are ineligible to enter the Contest and in case they do participate by misrepresentation, then Company/Producer shall in its sole discretion discontinue / disqualify such Participants' participation.
- "Contest": General knowledge quiz for Home Viewers entitled "Airtel Prasna Maadi Padivelu Meedi".
- 3. "APM Question": A question aired to call for entries for Airtel Prasna Maadi Padivelu Meedi'
- 4. "Shortlisted Participant (s)": A list of Participants per episodes who have given correct answer to a APM Question in the valid format and have been selected through a random selection for callouts
- 5. **"Episode Winner":** The Shortlisted Participant who has answered the APM question correctly in the valid format and is selected. The Episode Winner is eligible for the Episode Prize.
- 6. **"Episode Prize (s)":** The prize money of INR 10,000/- (Rupees Ten Thousands Only) that the Episode Winner is eligible for subject to taxes governing the state and country, as may apply.
- 7. "Show": "Meelo Evaru Koteeswarudu Season 4 which is being produced by the Producer for initial exhibition on the Channel. It also includes, but is not limited to, recordings of the Contest in the Studio (including any seasonal *special(s)* recording).
- 8. "Home Viewers": Persons viewing the Show during its initial exhibition on the Channel
- 9. **"Episode**" An episode of the Show.
- 10. "Producer": means the Producer of the Show which is Big Synergy Media Ltd.
- 11. "Rules and Regulations": These Rules and Regulations governing the said Contest, stated herein in entirety, as may be amended from time to time at the sole discretion of the Company.

# **III. PROCEDURE TO PARTICIPATE IN THE CONTEST:**

# **Questions on air**

- 1. The home viewer questions will be aired from 13<sup>th</sup> February 2017 to 18<sup>th</sup> May 2017 during the Monday to Thursday episodes of the Show. The question for the Contest will be broadcast at any given time between 21:30:00 hours to 22:30:00 hours of the day of Show Episode Telecast (Monday/Tuesday/Wednesday/Thursday), or around that time, as determined by Channel management. Post the completion of the Episode, the question will be available on the website (mek.maatv.com) until the closure of lines.
- 2. This Contest is open only to Airtel subscribers registered in the Telangana & Andhra Pradesh circles. They can participate in the Contest by calling on the IVRS or by sending an SMS through their Airtel Mobile Numbers from the Telangana & Andhra Pradesh circle. The telephone lines (mobile) and SMS acceptance for each question shall be as per the following schedule:

1. - 2. The cellular number from which the registration is received will be used to identify the Participant as a unique identification number.   - c. The acknowledgement message will read "Thank you for participating in APM Contest. We will call you back on this number if you are shortlisted. Upto Rs. 5/SMS. ". For purposes of these Terms and Conditions, "receipt" of the SMS occurs when the entrant receives the aforementioned acknowledgment message. Any other automated receipt confirmation does not constitute proof of actual receipt. For the avoidance of doubt, by submitting the SMS entry, the Participant(s) is representing that the SMS or contents thereof are not confidential or comprise any sensitive personal information. Please check T&Cs on mek.maatv.com

- b. The call will end with a thank you note/play back option. Thank you message will inform Participants that if they are selected, they will be called back on the same number.

## 6. CHARGES:

SMS: Every SMS sent to the participation numbers will be charged as mentioned below: Upto Rs.5 /- per SMS – 509095 (AIRTEL Subscribers).

SMS sent in the wrong format or with the incorrect answer are also chargeable.

IVR: All calls made to the participation numbers will be charged as below.

Upto Rs.5/- per minute – 509095 (AIRTEL Subscribers from the Telangana & Andhra Pradesh circles)

### **Episode Winner Selection**

- 1. A winner will be selected from all valid and correct entries for each question. All telephone numbers that have been selected as Winners for any of the previous episodes shall not be selected as Winners for subsequent episodes.
- 2. A list of 10 shortlisted Participants will be selected by the randomizer. A telephonic call will be made to the Participant shortlisted 1st in the list of 10 shortlisted Participants. If the 1st call is unsuccessful, 2 more attempts will be made to connect with the Participant, each after 15 minutes interval. In case all the 3 attempts are unsuccessful, call will be made to the next Participant on the list. In case all 3 attempts to all 10 shortlisted Participants are unsuccessful, another shortlist of 10 participants will be generated using the randomizer software. All such decisions shall be final and binding on the Participant(s). The Shortlisted Participants will be asked to provide the following details:
  - a. Name of the Shortlisted Participant
  - b. Age and date of birth of the Shortlisted Participant
  - c. Nationality of the Shortlisted Participant
  - d. City of the Shortlisted Participant
- 3. Calls to the Shortlisted Participant will be made in the order in which the randomizer has shortlisted the Participants. The Episode Winner of the Contest will be selected if the Shortlisted participant is 18 years or above and is an Indian citizen. A Shortlisted Participant who has already been declared as an Episode Winner of the Contest in any previous Episode of the Show will not be eligible to be declared as an Episode Winner for future Episodes. The Channel reserves the right to not award the prize money to the same Winner more than once.
- 4. The randomization process to select the Shortlisting Participant(s) will be undertaken with the help of randomizer software developed specifically for the purpose of selection. In the event of a software failure, Channel management may adopt any other methodology or criteria to select the Shortlisted Participants, depending upon requirement and availability of time.
- Timelines and methodology of determining winners are subject to change based on programming / creative requirements, degree of participation, technical issues, force majeure reasons, etc.

# **Call back**

- 1. Channel and Company are not responsible if the call-back is not successful due to:
  - a. Line being busy
  - b. Congestion on the network
  - c. No answer received
  - d. Poor call conditions / unclear reception e. Number engaged
  - f. Call drop

- g. Other reasons that could render a call unsuccessful or terminate it.
- 2. In-spite of making 3 attempts for all Shortlisted Participants, if the Company / Producer is unable to contact them, the Company shall not be held responsible by the Shortlisted Participant on grounds of not being contacted.
- 3. The selected Participant will receive a call from the Company / Producer and the selected Participant must provide with the details asked for by the Company / Producer immediately. The Company/ Producer will ask the Participant to confirm if he/she has sent the Entry for participation in the Contest. If the confirmation required or the other information asked for is not provided on the call, then the Company / Producer will call the Shortlisted Participant twice again after a n i n t e r v a l o f 15 minutes each, asking for the same details. Failure to provide such details during the third call shall lead to disqualification of such Participant from the selection process. The Company will attempt to arrange for the call backs between 9 am and 9 pm only.
- 4. The first person who answers the registered phone number and claims/confirms that he/she is the Participant, will be considered as the Participant as per the Rules and Regulations of the Contest. The Company / Producer will not be responsible to determine the correct Participant in the event of more than one Home Viewer having participated from a particular number, or the incorrect person answers the call and claims to be the Participant, or refuses to permit the actual Participant to continue the call.
- 5. Company will use their best efforts to contact the selected Participant, but will not be responsible or liable in any way whatsoever if the Participant cannot be reached by telephone, on the number provided, in next 2 attempts after initial contact is made or after the first attempt of reaching the Participant
- 6. The following process will be followed by the Company / Producer once connected with the randomly selected Shortlisted Participants for the telephonic call-back:
  - a. Company will use their best efforts to contact the selected Participant, but will not be responsible or liable in any way whatsoever if the Participant cannot be reached by telephone, on the number provided, within the next 2 attempts at an interval of 15 mins each after initial contact is made or after the first attempt of reaching the Participant
  - b. In-spite of making 3 attempts for all Shortlisted Participants, if the Company / Producer is unable to contact them, the Company shall not be held responsible by the Shortlisted Participant on grounds of not being contacted.
  - c. If the receiver of the call confirms that he/she is the Participant, then the Participant will have to choose between Telugu & English language options.
  - d. The Company / Producer will then ask the Participant to provide his/her Name, Age, Date of Birth and Address and Nationality
  - e. The Company / Producer will confirm the details provided by the Participant
  - f. If the Participant is a minor and/or Participant's nationality is not Indian and/or has won in the previous questions of the APM contest, then only one further opportunity will be provided to such selected Participant to revise/ confirm their answer, after which the call will be terminated and the Participant deemed disqualified and thus ineligible to receive the prize money.
  - g. A shortlisted participant is eligible to win the APM prize money only once during the

- entire contest of the season. If at any point, the Company determines that the Participant has already won in the previous questions then the Participant shall be deemed disqualified and thus ineligible to receive the prize money.
- h. If the details match, the Episode Winner will be declared on the Monday episode of the subsequent week.
- 8. The call back process made by the Company/Producer to the Shortlisted Participant will be recorded.

# Winner Declaration and Pay-out

- 1. The Shortlisted Participant selected as the Episode Winner is required to send selfattested copies of one of the following documents as valid name, citizenship and age proof to support the claim as per the call back process, by Registered AD post within 7 working days from date of the call.
  - a. Passport
  - b. Voter's ID
  - c. Driver's License
  - d. UID / Aadhar card

In addition, the Participant is required to send self-attested copies of one of the following documents as valid address proof:

- a. Passport
- b. Voter's ID
- c. Driver's License
- d. Ration Card
- e. UID / Aadhar Card

Apart from the above documents the Shortlisted Participant would also need to share a bank certificate on the respective banks letter head verifying the account details for Shortlisted Participant.

- 2 In addition, the Episode Winner is required to send in a self-attested copy of his / her PAN card. PAN card copy and bank certificate (verifying the Winner's bank account credentials) are compulsory for pay-out. After receipt and verification of the following documents, the Company will send the Winner a copy of a Release Form which needs to be signed by the Winner and returned to the Company. The payment will be issued only on the basis of receipt of a signed Release Form.

The Company will not be responsible in case of any delays or loss of the documents in transit and no requests / complaints will be entertained with respect to the same.

4. Upon completion of successful verification, the Participant will be declared as the Episode Winner and will be paid out as per the standard payment process followed by the Company. Tax will be deducted at source for any such payment, as per applicable rates.

# **IV. GENERAL TERMS AND CONDITIONS**

### **Participants**

- 1. Participation in the Contest by sending Entries in any manner as described herein shall be considered to be acceptance of these Rules and Regulations.
- 2. Contest is open to citizens of India who have completed 18 years of age on the date of participating in the Contest, and the citizen should be of sound health and mind.
- 3. Persons must enter the Contest on their own behalf and entry(ies) by proxy will not be accepted, even for their immediate family members.
- 4. An entry is not transferrable.
- 5. Employees of the Company, Producer, the advertising agency, appointed from time to time, other related parties, employees of the main sponsors and members of their immediate family; persons other than Indian nationals, or Indian nationals living out of India, or those who do not qualify under the definition of resident of India as per the Income Tax Act, 1961 or those not conversant in spoken Telugu, are ineligible to enter the Contest. Failure to provide proof or affidavit of eligibility, including the correct date of birth within the defined time, upon request by the Company may result in disqualification and non-payout of prize. The Company also reserves the right to disqualify a Participant in case a discrepancy is found to exist in the information furnished/provided/stated by the Participant during the conversation with the Producer / Company or any of the Company's sub-contractors and vendors used by them in the Contest, and in the information stated in the documents furnished by the Participant.
- 6. The Participant hereby represents that he / she is not under any exclusive contracts with any other third party / agency or is not under any kind of disqualification under law to participate in the Contest, as the case may be.
- 7. The Participant shall undertake, warrant and guarantee to the Company that the Participant has the full legal capacity to participate in the Contest in accordance with these Contest Rules.
- 8. The Participant(s) shall acknowledge that he/she has voluntarily chosen to participate in the Contest at his / her free-will and is willing to bear all risk, costs & consequences arising from such participation in the Contest.
- 9. If entries are received for participation, it is assumed that the person sending in the entry has provided us with permission to send SMSs to or call him / her, whether or not such sender is registered on the National Do Not Call registry

### <u>Information</u>

- 10. Participant is required to furnish necessary supporting documentation which is in English / Telugu language only (refer list of documents in Winner Declaration and Pay-out section or any such document as requested by the Company) to confirm the eligibility of the Participant.
- 11. Participant (s) is / are required to send the necessary supporting documentation to the Company within 7 working days from receipt of the call via Registered AD post only. Failure to comply with the above, will result in disqualification and subsequent ineligibility to receive the prize money. Proof of delivery to Company is not eligible as a proof of receipt by the Company.
- 12. Company may, at its discretion contact the Participant(s), if required, for any clarifications needed for the information provided in the participation entry.
- 13. The Company has the right at any time to require proof of identity and/or eligibility. Failure to provide such proof within a reasonable time could result in disqualification from the Contest and subsequent ineligibility to receive the prize money.
- 14. In case there is any mismatch of Participant(s) details in any round of the Contest, the

- Participant(s) will be disqualified and subsequently become ineligible to receive the prize money.
- 15. Disbursement timelines of prize money will be at the discretion of the Company as per its standard day-to-day operating payment procedure.
- 16. All personal details and information requested by and supplied to the Company by each Participant must be truthful, accurate and in no way misleading. The Company reserves the right to disqualify any Participant from the Contest at its sole discretion, should the Participant at any stage supply untruthful, inaccurate or misleading personal details and/or information.
- 17. If at any time, including after disbursement of prize, any information submitted by the Participant(s) is found to be incorrect, false, or otherwise misrepresented or misleading, the Participant(s) shall be liable to refund all amounts received from the Company.

## Speaking to the media and third persons

18. None of the Participants shall, without the prior written approval of the Company, speak to the press or any other media or any third person, nor give any interviews or comments relating to any aspect of the Contest or write blogs, post any messages in social networking or any site including but not limited to Facebook and Twitter. The Participant shall not disclose any information whatsoever relating to the Company, or the Contest to any other party.

# **Telephony**

- 19. In the event the Participant uses a phone not registered in his name for participation, the Company will not be responsible to track the Participant.
- 20. In case the Company is unable to reach the Participant, the participation entry will be deemed as invalid.
- 21. In the event is it not possible to determine with certainty the person who participated from a particular telephone number, that entry would be disqualified. Participants are requested to use phone numbers which are unique to them and where they do not foresee such difficulties.
- 22. Company / Producer shall not be liable for any failure of the IVR or SMS server or system, or incomplete entries submitted by Participant(s).
- 23. Post submission of the entry via SMS or IVR, the Participant(s) will not be permitted to modify / alter / change answer submitted.
- 24. Only the Entries received after the Contest questions are broadcast on the Channel will be considered valid. Time of receipt of Entry will be the time of receipt at the servers of the telephony partners contracted by the Company. For IVR, the call start date and time will be considered.
- 25. The Company shall endeavor to make all reasonably practicable arrangements to minimize telephone system difficulties, ensure uptime of systems, back-up of data, telephone system capacity, and prevent other technical impediments, but can make no guarantee thereof.
- 26. Company and its sub-contractors are not responsible for delayed receipt or non-receipt or incomplete receipt or corrupt receipt of participation entries.
- 27. The Company shall not be responsible and/or liable in any manner whatsoever in case the Participant(s) are unable to participate in the entry process due to failure on the part of the telecom operator, facility provider, etc., or due to capacity constraints.

# Winner Declaration
