- b.promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activity that may appear unsafe or dangerous.
- c. is obscene or offensive; endorses any form of hate or hate group.
- d. appears to duplicate any other submitted Entries.
- e. defames, misrepresents or contains disparaging remarks about other people, companies, or organizations.
- f. contains materials embodying the names, likenesses, voices, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission.

#### **JUDGING**

- (i) After the last date, all eligible entries, received during the Contest Period, will be evaluated by a panel of judges.
- (ii) A maximum of 70 top videos will be short-listed, based on the following criteria (weighted equally):
- (a) Message(s) being communicated through the Video
  - (b) Creativity
  - (c) Level of entertainment
- (iii) Once video selection is completed, the Finalists will be contacted through email or phone by **May 3**, **2017**.

If you have not been contacted by this date, you may assume that your video has not been short-listed. Depending on the number of submissions, entries not chosen in one month may be eligible for the following month.

# FINALIST/WINNER NOTIFICATION

The decision of UIDAI will be final on all matters relating to this Contest. Winners will be notified by telephone or email and may be required to complete a Declaration, or provide a Certificate of relationship (Birth Certificate, etc.) with the participant.





First 20 best videos will be awarded a cash prize of Rs.5,000/- and the next 50 videos will get a prize of Rs.1,000/-. Prize money will be sent to Aadhaar-linked bank account only.
