## Terms and Conditions for "Sabse Bada Kalakar" Contest

The following terms and conditions ("**T&Cs**"/ "**Terms and Conditions**") shall be applicable to Sony Pictures Networks India Private Limited (Formerly known as Multi Screen Media Pvt. The T&Cs shall be in two parts (a) Specific T&Cs for each Contest and Basic T&Cs for the Contest.

## "Basic T&Cs":
