The Quiz is valid and open for a limited period from 10th July 2017 08:00:00 hrs till 7th September 2017 22:00:00 hrs, both days inclusive, for the active pre-paid as well as post-paid category of Airtel Subscriber(s)2 ("Subscriber(s)") who have successfully subscribed to the Victory Zone ("Victory Zone Member(s)"), in accordance with the subscription process mentioned below (Airtel means Bharti Airtel Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Bharti Crescent, 1, Nelson Mandela Road, Vasant Kunj, Phase II, New Delhi – 110 070, India (hereinafter referred to as "Airtel") and who belong to the following Airtel telecom circles ("Circle(s)") of DELHI, UTTAR-PRADESH-WEST, UTTAR PRADESH EAST, JAMMU & KASHMIR, PUNJAB & HARYANA & HIMACHAL PRADESH, ANDHRA-PRADESH, KERALA, KARNATAKA, MUMBAI, MAHARASTRA, GUJARAT, MADHYA-PRADESH, RAJASTHAN, KOLKATA & WEST BENGAL, ORISSA, BIHAR, NORTH EAST & ASSAM, TAMIL NADU AND CHENNAI. 6. Charging (Price points including Fall-back pricing):

i. Subscription charges shall apply as follows:

Subscribers that do not have Rs49 balance will be charged Rs. 30 Subscribers that do not have Rs30 balance will be charged Rs. 20 Subscribers that do not have Rs20 balance will be charged Rs. 10 Subscribers that do not have Rs10 balance will be charged Rs. 5 Subscribers that do not have Rs5 balance will be charged Rs. 4 Subscribers that do not have Rs4 balance will be charged Rs. 3 Subscribers that do not have Rs3 balance will be charged Rs. 2 Subscribers that do not have Rs2 balance will be charged Re. 1

- ii. All Victory Zone Members will be charged depending on the balance available on the Subscriber's MSISDN registered with Airtel for that day from 01:00:006 hours onwards, from the date of commencement of the Quiz or from the day Victory Zone Member subscribes to Victory Zone till the end of the Quiz, or till the day Victory Zone Member unsubscribes from the Victory Zone, whichever happens first, irrespective of whether the Victory Zone Member plays the Quiz or not. The Charging Amount is charged for 60 days This Charging Amount will not be refunded to Victory Zone Member under any circumstances. Only Charged users will be allowed to play the Quiz.
- iii. At a regular interval of 15 days, from the date of commencement of the Quiz till its completion, all active Victory Zone Members will be sent a reminder SMS on their MSISDNs registered with Airtel, informing them that they are active on Victory Zone and such SMS shall detail the process of un-subscription from the Victory Zone and the number on which Victory Zone Member can call and re-participate in the Quiz.
- iv. All the Victory Zone Members will be allowed to play the respective number of questions as per the fallback prices below irrespective of the amount that has been charged. However, for the purpose of Winner selection, correct answers to only those questions shall be considered, which are eligible to be considered, based on the amount charged on a particular day:

Subscribers that are charged Rs.49 are eligible for 49 questions

Subscribers that are charged Rs.30 are eligible for 30 questions

⁶The Daily Charging Amount as applicable per Victory Zone Member will be done through an automated charging system, where the system will automatically charge all the existing Victory Zone Member the Daily Charging Amount per day, depending on the available balance on Subscriber MSISDN registered with Airtel.

Subscribers that are charged Rs.20 are eligible for 20 questions

Subscribers that are charged Rs.10 are eligible for 10 questions

Subscribers that are charged Rs.5 are eligible for 5 questions

Subscribers that are charged Rs.4 are eligible for 4 questions

Subscribers that are charged Rs.3 are eligible for 3 questions

Subscribers that are charged Rs.2 are eligible for 2 questions

Subscribers that are charged Re.1 are eligible for 1 question

7. Playing / Rules:

- A Victory Zone Member can play only up to 49 questions with 2 answer options for each question. All questions are in multiple choice format and the answer to each must be selected from one of the 2 options only.
- The questions under the Quiz shall be based on information available to the public at large.
- After every answer, the Victory Zone Member will be informed if the given answer is right or
 wrong, followed by the updated score and given the next question and answer options. The
 Victory Zone Member shall also be informed the total score which shall be based on the days
 of successful charging (which will consider the charging and score update the day before the
 previous day).
- For every right answer the Victory Zone Member will get 1 point. There is no negative marking for a wrong answer.
- If the Victory Zone Member stops playing the Quiz after answering the nth question then when Victory Zone Member resumes playing on the same day by calling the number 550001 (toll free) or sending the keyword 'CAR' through SMS to 550001 (toll free), Victory Zone Member will be given (n+1)th question. If Victory Zone Member stops playing the Quiz without answering the nth question then when Victory Zone Member resumes playing on the same Quiz, Victory Zone Member will be given the nth question, which may be different than the question received previously.
- Irrespective of whether or not the Victory Zone Member has answered all 49 questions on a particular Quiz, when Victory Zone Member attempts on the next Bumper Quiz, Victory Zone Member will be provided the first question of that Month.
- The Victory Zone Member will be provided the questions one after the other till Victory Zone Member finishes answering all the questions for that particular Quiz.
- There will be a black-out time for the Quiz on last day of the Quiz between 11:45 PM and 12:15 AM of the next day. This black-out time will be communicated to all the Victory Zone Members at the time of subscription to Victory Zone. During this black-out period, the Victory Zone Members will not be allowed to play the Quiz. If the Victory Zone Members send responses after 12:15AM, then that will be considered as a response to the 1st question of the new Bumper Quiz and based on the right answer configured for the 1st question of such Quiz, the response will be sent along with the next question and answer options.
- The selection of the Winner for the Monthly Prize for each Month of the Quiz will be based only on the points scored by a Victory Zone Member on each Month of the Quiz.
- If a Victory Zone Member has answered only 48th questions the previous Quiz and sends the answer to the 49th question the next Quiz, then that will be considered as the answer to the 1st question of the new Quiz and response will be sent accordingly if the 1st question has been pushed to the Victory Zone Member.
- Victory Zone Members who are roaming outside their home Circles will not be barred from subscribing to the Victory Zone and/or participating in the Quiz.

- Fall back questions will be charged at Re1/question. If the user is charged on any fall back and has answered the allotted question(s), then the user can answer the remaining question(s) at Re. 1 per Question. For Example, if user is charged Rs. 30 and has played all 30 questions, the system will send a prompt for the remaining 19 questions to be charged at Re. 1 per question; the same will apply for all fall backs of Rs20, Rs. 10, Rs. 5, Rs. 4, Rs. 3, Rs. 2 and Re. 1 respectively.
- If the user has not played all the allotted questions, then the user is able to play the remaining questions any time within the Quiz period.
- If a Victory Zone Member subscribes to the Quiz after few days of the launch date, then also Victory Zone Member will be able to play all allotted question of the Quiz during the Quiz period.

8. Quiz on Call:

- i. All Victory Zone Members can play the Quiz by calling the toll-free number 550001.
- ii. The Victory Zone Members can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer any question.
- iii. Victory Zone Members can press * to listen to a question again.

9. Ouiz on SMS:

- i. The Quiz will be available on the toll-free number 550001 for Victory Zone Members.
- ii. All Victory Zone Members can play the Quiz, on the toll-free number 550001, by sending 'CAR' to 550001.
 - iii. A Victory Zone Member can play the Quiz either by sending the keyword CAR as an SMS to 550001 to get the question and answer options followed by sending CAR A or CAR B or just 'A' or 'B' as an (without "CAR") SMS to 550001 as their response to the question that Victory Zone Member has last received on that particular day.
- iv. In case a Victory Zone Member experiences a delay in receiving a response or receives no response at all from the system at any time during the Quiz, Victory Zone Member is required to send an SMS with the Quiz keyword CAR to the toll-free number, 550001. The Victory Zone Member should refrain from sending the answer options, 'A' or 'B' in such a situation, as it may be considered as a reply to an unanswered question.

10. Prizes and Winner Selection process:

Bumper Prize

The selection for the Bumper Prize winner will be conducted after the Quiz ends.

1 MSISDN across circle groups*, with the minimum cumulative score of 49 points in the least amount of time during the Quiz, will be selected as the winner of a Hyundai EON Car worth up to Rs3,33,000

Assured Prize

<u>First 1000 MSISDNs across circle groups*</u>, who scores 5 points during the Quiz, are selected as the winners of Mobile Recharge worth up to Rs50.

Early Bird Prize

<u>First 1000 MSISDNs across circle groups*</u>, who scores 1 point during the Quiz, are selected as the winners of Mobile Recharge worth up to Rs20.

The points scored by an MSISDN from the questions that the MSISDN is entitled to answer in a Quiz, based on that charged value will only be considered for selection.

In the selection of the Bumper Prize, in case of a tie in the score and in the time taken to answer, 1 round of tie-breaker will be conducted on voice for all the tied MSISDNs. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be Considered.

The time taken for answering a question on "Voice" mode, is calculated from the time OnMobile's system plays beep (after question) till the answer DTMF input received by the system. On SMS channel time taken is calculated from the time system pushes the question till the answer input received by the system.

A Subscriber is eligible to win more than one Prize during the period of the Quiz, which means that he/she can win more than one Prize provided he/she meets the above said criteria of the respective Prizes and gets selected by the random selector in case of a tie.

Note: If a participant plays the Quiz over both the channels (Voice & SMS), his/her score will only be cumulative, and not exclusive for each of the channels. i.e.: if the participant has started playing the Quiz on voice and has scored 2 points in 3 questions, if he/she drops the call and resumes playing through SMS, he/she will be given the 4th question, and if he/she answers the question correctly, his/her score will be 3. And this will be the score that will be considered for the winner selection for all the prizes.

All subscribers will be able to answer all 49 questions.
