Terms and Conditions of 'Summer Bonanza' Contest

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS "'Summer Bonanza' Contest". BY PROCEEDING WITH PLAYING THE 'Summer Bonanza' Contest, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("Terms and Conditions"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE 'Summer Bonanza' Contest.

Terms and Conditions

- 1. This Contest is open for participation for the active¹ pre-paid and post-paid category of Subscribers² ("Subscriber(s)") of TTL, during the period from [20th April'15 00:00:01 hrs to 18th June'15 23:59:59 hrs), both days inclusive (hereinafter referred to as the "Contest Duration"). TTL and Partners reserves the right to extend or shorten the Contest Duration as it deems fit.
- 2. This Contest is organized by TTL and sponsored by **OnMobile Global Limited**, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India ("**OnMobile**" or "**Partner**").

The Subscribers understand that the prize/s under the Contest are sponsored and provided by Partner as mentioned above and TTL shall not be held responsible or liable for non-delivery or shortfall or deficiency in the prize/s and all the legal remedies in

relation to the prizes shall solely lie against the Partner, subject to these Terms and Conditions.

3. The Contest is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 4 below and who belong to the following TTL telecom circles ("Circle(s)") of ANDHRA PRADESH, BIHAR, DELHI, GUJARAT, HARYANA, KARNATAKA, KERALA, MAHARASTRA, MADHYA PRADESH, ORISSA, MUMBAI, PUNJAB, HIMACHAL PRADESH, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, KOLKATA, WEST BENGAL, CHENNAI and TAMIL NADU and who have successfully subscribed to the Contest by following the process mentioned hereunder. Notwithstanding the foregoing, if the operation of or participation in the Contest is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such State and/or territory or part thereof shall not be eligible to subscribe to or participate in the Contest. 4. Eligibility

- Warrant the accuracy, truthfulness and correctness of all information that You have submitted; and
- Warrant that prior to participating in the Contest, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.

The Contest will be available in English and Hindi languages on Interactive Voice Response ("IVR").

A Subscriber, by participating in the Contest, hereby agrees to these Terms and Conditions and gives his/her irrevocable consent to the process of selecting the Winners (detailed below) under this Contest as set out herein, and any appropriate changes that may be made to this Contest by TTL including due to any legal, statutory or regulatory requirement, business exigencies, instructions from any judicial or a quasijudicial body or due to any natural calamity beyond the reasonable control of the TTL or Partners, its affiliates and associates or for any reason whatsoever.

6. Contest

If the Subscriber stops playing the Contest after answering the nth question then when he/she calls back on the toll free number 543218, he/she will be played the (n+1)th question. Bumper Prize: The selection for the Bumper Prize Winner will be conducted after the Contest ends. One MSISDN across all Circle-Groups, as per the schedule of Circle-Groups* given below, who score the maximum points, in the least number of questions, during the Contest Duration will be selected as the Winner of a TATA NANO car worth up to Rs 200,000/-.
