

## **TERMS AND CONDITIONS FOR WIN GOLD**

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS CONTEST KNOWN AS “**WIN GOLD**” or “the **CONTEST**”. BY PROCEEDING WITH PLAYING THE **CONTEST**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**Terms and Conditions**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN **CONTEST**.

### **Terms and Conditions**

1. **WIN GOLD** (hereinafter referred to as the “**Contest**”) is conceptualized and organized by Tata Teleservices Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Jeevan Bharti, 10th Floor, Tower-I, 124, Connaught Circus, New Delhi- 110001 and its corporate office at A & E Blocks, Voltas Premises, T. B. Kadam Marg, Chinchpokli, Mumbai - 400033 and Tata Teleservices (Maharashtra) Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Voltas Premises, T.B.Kadam Marg, Chinchpokli, Mumbai - 400 033 (collectively referred herein as “**TTL**” or “operator”). This Contest is open for participation for the active<sup>1</sup> pre-paid and post-paid category of Subscribers<sup>2</sup> (“**Subscriber(s)**”) of TTL, during the period from 26<sup>th</sup> JULY, 2017 00:00:01hrs to 23<sup>rd</sup> September, 2017 23:59:59hrs, both days inclusive (hereinafter referred to as the “**Contest Duration**”).
2. This Contest is organized by TTL and sponsored by **OnMobile Global Limited**, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India (“**OnMobile**” or “**Partner**”). TTL and Partner reserves the right to extend or shorten the Contest Duration as it deems fit.
3. TTL and OnMobile shall hereinafter be jointly or individually as the context may require be referred to as “**Organizer/s**”

The Subscribers understand that the gratification/s under the Contest are sponsored and provided by Partner as mentioned above and TTL shall not be held responsible or liable for non-delivery or shortfall. subject to the Terms and Conditions of the Contest.

<sup>1</sup>An active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in Contests offered by Partners and TTL, jointly.

<sup>2</sup>Subscriber shall mean the rightful user of the TTL India connection, pre-paid or post-paid, in whose name the mobile phone connection number (MSISDN) is registered with the operator. In the event the number / connection is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Contest, receive the gratifications and accept the terms applicable for the Contest.

4. **The Contest is open for all active subscribers of TTL telecom circles (“Circle(s)”)** of DELHI, RAJASTHAN, MUMBAI, MAHARASHTRA, KARNATAKA, KERALA, MADHYA PRADESH, GUJARAT, ANDHRA PRADESH, TAMIL-NADU & CHENNAI, UTTAR-PRADESH EAST, UTTAR-PRADESH WEST, PUNJAB, HARYANA, HIMACHAL PRADESH, BIHAR, ORISSA, KOLKATA, WEST BENGAL and who have successfully subscribed to the Contest by following the process mentioned hereunder. Notwithstanding the foregoing, if the operation of or participation in the Contest is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such State and/or territory or part thereof shall not be eligible to subscribe to or participate in the Contest. No further notice shall be given by Partner or TTL in this regard to the Subscribers.

5. **Eligibility:**

- Subscriber must be of or above 18 years of age;
- Subscriber must be a resident of India;
- Subscriber must belong to any one of the Circles mentioned in these Terms and conditions;
- The name and address of the Subscriber must at all times correspond with the name and address of such Subscriber as is registered with TTL during the Contest Duration and on the date of Winner selection and distribution of gratifications under this Contest unless otherwise expressly authorized in writing by TTL.
- Subscribers must maintain a minimum balance of Rs.5/- to play the Contest.
- Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. and /or is prohibited from entering into any contractual relationship.

For the purposes of these Terms and Conditions, wherever the context so requires **“You”** or **“Your”** shall mean any natural person who is a Subscriber.

Also, by participating in this Contest, You:

- Agree to these Terms and Conditions and give Your consent for the same;
- Agree that You are entering into this Contest as an independent party and nothing herein establishes an employer-employee relationship between You and TTL or between You and Partners and You are acting voluntarily, using Your own time and resources to participate in this Contest, solely at Your own risk;
- Warrant that You have read, understood and agreed to conform to these Terms and Conditions;
- Warrant the accuracy, truthfulness and correctness of all information that You have submitted; and
- Warrant that prior to subscribing to the Contest, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.

6. The Contest will be available in English and Hindi languages on Interactive Voice Response (“IVR”) and in English and Hinglish on Short Message Service (“SMS”). The contest shall be called WIN GOLD Contest across all circles. It might be possible that user gets only 1 language option on IVR basis circle preferred language as decided by the operator.

A Subscriber, by participating in the Contest, hereby agrees to these Terms and Conditions and gives the Subscriber’s irrevocable consent to the process of selecting the Winners (**“Selection Methodology”**) under this Contest as set out herein, and any appropriate changes that may be made to this Contest by Organizer including due to any legal or regulatory requirement, business exigencies, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the TTL or Partner, its affiliates and associates or for any reason whatsoever. Subscribers roaming outside their Circle shall be barred from playing the Contest. Further, the Subscribers who participate in the Contest and are chosen as Winners of each category of gratification in accordance with the Winner selection process under the Terms and Conditions of the Contest shall be required to be the registered TTL Subscribers of the winning mobile phone number and not merely the players using such mobile number (**“Winner(s)”**). If the Winner is not able to provide sufficient evidence to show that declared winner is the Subscriber of the mobile connection, Organizer’s reserves the right to award the prize to the next eligible Winner.

7. The participation in this Contest is purely voluntary.
8. The Subscribers may subscribe to this Contest by calling the toll-free number 543218 or sending an SMS to the toll-free number 543218 with the Key word “WIN” or any other keyword. It is clarified that any other keyword can be any random word input send by the Participant other than START, STOP, SCORE, PRI, RUL, TNC and this will in turn initiate the question for Subscriber
9. It is also clarified that a Subscriber may participate in this Contest only through IVR and SMS. Each Subscriber shall be charged Rs5/- per Answer, during the Contest Duration.

If the charging is unsuccessful, a ‘not charged’ prompt shall be played to the Subscriber and the call will be dropped. The answer given by the Subscriber for such uncharged question shall not be considered for the purposes of this Contest and such question will remain as an unanswered question, which may be played to the Subscriber again, during the Contest Duration.

In case of Low balance, a low balance prompt will be played and the call will be dropped.

If a Subscriber wants to unsubscribe from the Contest then it can be done by sending STOP as an SMS to 543218 (toll-free). Upon effective un-subscription, an SMS will be sent to the Subscriber, confirming the un-subscription from the Contest.

- Once a user calls 543218 or sends an SMS to 543218, the system checks if the caller has already subscribed to the contest or not. The above mentioned charges shall be deducted immediately after the recharge is done by the Subscriber.

#### 10. Contest on Voice

The Contest consists of total 50 questions, with 2 answer options for each question and the Subscribers can answer the questions by pressing 1 or 2 on their mobile phone keypad. All questions are in multiple choice format and the answer to each must be selected from one of the two options only.

The Subscribers may answer any number of questions on a particular day at their discretion. The Subscribers will be played the questions one after the other till the Subscriber finishes answering all the questions of the Contest.

The questions under the Contest shall be based on general information available to public at large.

For all Subscribers who participate in the Contest for the first time by dialing 543218, a Subscriber will be able to hear the information informing them about the gratifications offered under the Contest, the charges per answer and the Terms and Conditions. This will be followed by the 1st question and answer options.

To listen to a question again the Subscriber can press \*. There will be no negative marking for a wrong answer.

For every right answer the Subscriber will be entitled to one point. After every answer, the Subscriber will be played an appropriate response followed by the updated score and given the next question.

If the Subscriber stops playing the Contest after answering the nth question then when the Subscriber calls back on the toll free number 543218, the Subscriber will be played the (n+1)th question. If the Subscriber stops playing the Contest without answering the nth question, then when the Subscriber calls back on the toll free number 543218, the Subscriber will be played the nth question, which may be different from what the Subscriber received previously, i.e., if the Subscriber listens to the 4th question but drops the call without answering the 4th question, then when the Subscriber calls

back, the Subscriber will be played the 4th question, which question maybe different from what the Subscriber received previously.

#### 11. Contest on SMS

The Contest consists of a total of 50 (fifty) questions, with 2 (two) answer options each and the Subscribers can answer the questions by sending A or B or 1 or 2 on their mobile phone keypad. The Subscribers may answer any number of questions on a particular day at their discretion. The Subscribers will receive the questions one after the other till subscriber finishes answering all the questions of the Contest.

The questions under the Contest shall be based on general information available to public at large.

For all Subscribers who participate in the Contest for the first time by sending the keyword WIN as an SMS to 543218, a welcome SMS will be sent to the Subscriber, informing them about the gratifications offered under the Contest, the charges per answer and the Terms and Conditions URL. This will be followed by the 1st question and answer options.

For every right answer the Subscriber will be entitled to 1 (one) point. After every answer, the Subscriber will be sent an appropriate response, with the updated score and given the next question and answer options. There will be no negative marking for a wrong answer.

If the Subscriber stops playing the Contest, then subscriber may resume playing the Contest by sending WIN or any other keyword except START, STOP, SCORE, PRI, RUL or TNC as an SMS to 543218 during Contest Duration, to receive the next question and answer options.

If the Subscriber stops playing the Contest after answering the nth question then when subscriber sends WIN or any other keyword except START, STOP, SCORE, PRI, RUL or TNC as an SMS on the toll free number 543218, subscriber will be played the (n+1)th question. If the Subscriber stops playing the Contest without answering the nth question, then when subscriber sends WIN or any other keyword except START, STOP, SCORE, PRI, RUL, TNC as an SMS on the toll free number 543218, subscriber will be played the nth question, which may be different from what subscriber received previously.

### 13. Selection Methodology

#### Super Bumper Prize:

The selection for the Super Bumper Prize will be conducted after the Contest ends.

1 MSISDN with the highest score in the least amount of time, during the contest will be selected as the winner of a Gold Card worth up to Rs1,50,000.

#### Bumper Prize:

The selection for the Bumper Prize will be conducted after Super Bumper Prize.

1 MSISDN with minimum 40 points in the least amount of time, during the contest will be selected as the winner of an LED TV worth up to Rs50,000.

Winner of Super Bumper Prize will not be eligible for this prize

#### Monthly Prize:

The selection for the Monthly Prize will be conducted after the Contest ends and as per the schedule\*\*.

1 MSISDN with minimum 25 points in the least amount of time, during that month will be selected as the winner of an Iphone7 worth up to Rs50,000.

1 MSISDN can win Monthly prize only once in the contest

1 Individual winner, irrespective of MSISDNs, can get only one of the above gratifications.

### **Friendship Day Special (5<sup>th</sup> and 6<sup>th</sup> August)**

The selection for the Friendship Day Special prize will be conducted as per the Friendship Day Special schedule\*\*\*\*\*

4 MSISDN with minimum 10 points in the least amount of time, during (5<sup>th</sup> and 6<sup>th</sup> August) will be selected as the winner of a Bank Gift Card worth up to Rs2500.

### **Independence Day Special (14<sup>th</sup> and 15<sup>th</sup> August)**

The selection for the Independence Day Special prize will be conducted as per the Independence Day Special schedule\*\*\*\*\*

4 MSISDN with minimum 10 points in the least amount of time, during (14<sup>th</sup> and 15<sup>th</sup> August) will be selected as the winner of a Bank Gift Card worth up to Rs2500.

Winner of Friendship Day Special prize will not be eligible for this prize.

### **Weekly Prize:**

The selection for the Weekly Prize will be conducted as per the schedule\*\*\*.

5 MSISDNs with minimum 12 points in the least amount of time, during that week, will be selected as the winner of Mobile Recharge worth up to Rs1000.

1 MSISDN can get the Weekly prize only once in the Contest.

### **Daily 1<sup>st</sup> Prize**

10 MSISDNs with minimum 6 points in the least amount of time on that day, will be selected as the winner of Mobile Recharge worth up to Rs100.

1 MSISDN can win the Daily 1<sup>st</sup> prize only once in this contest

The winning MSISDN will be removed from the list of eligible MSISDNs for Daily 2<sup>nd</sup> & 3<sup>rd</sup> prize of that day.

### **Daily 2<sup>nd</sup> Prize**

30 MSISDNs with minimum score of 4 points in the least amount of time on that day, will be selected as the winner of Mobile Recharge worth up to Rs50.

1 MSISDN can win the Daily 2<sup>nd</sup> prize only once in this contest

The winning MSISDN will be removed from the list of eligible MSISDNs for Daily 3<sup>rd</sup> prize of that day.

### **Daily 3<sup>rd</sup> Prize**

50 MSISDNs with minimum score of 2 point in the least amount of time on that day, will be selected as the winner of Mobile Recharge worth up to Rs30.

1 MSISDN can win the Daily 3<sup>rd</sup> prize only once in this contest

### **Daily Early Bird**

First 100 MSISDNs daily who scores 1 point, will be selected as the winner of Rs20 worth Recharge Code.

1 MSISDN can win the Daily Early Bird prize only once in this contest.

In the selection of the Super Bumper, Bumper, Monthly prize, Independence Day Special and Friendship Day Special prize in case of a tie in the score & time taken, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. Winner of tie-breaker round will be the MSISDN with highest score in least amount of time. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer  $35-1=34$  questions will be considered. In case of a tie in this, then the time taken to answer  $34-1=33$  questions, and so on will be considered.

In case of a tie in the selection of winners for any of the weekly & Daily gratifications, in the Contest, the Winner will be the MSISDN that has achieved the relevant score as detailed above, first in point of time, which shall be electronically recorded by an independent system of the Organizer.

For winner selection first question time taken will not be considered.

The time taken for answering a question through the "Voice" mode or SMS on a day, is calculated from the time OnMobile's system receives the 1st answer from an MSISDN till the time OnMobile's system receives the respective last correct answers from that MSISDN on that day, for the purposes of determining the relevant gratifications under this Contest, respectively. The total time taken by an MSISDN to provide the correct answers in a day, whether on Voice or SMS is used to determine the Winners for the afore-mentioned gratifications.

A Subscriber is eligible to win more than one Prize during the period of the Contest, which means that the Subscriber can win more than one Prize provided the Subscriber meets the above said criteria of the respective Gratifications.

Note: If a participant plays the Contest over any of the available channels (IVR & SMS), the Subscriber's score will only be cumulative and not exclusive for each of the channels. ie: if the participant has started playing the Contest on voice and has scored 2 points in 3 questions, if the Subscriber drops the call and resumes playing through SMS, the Subscriber



will be given the 4th question, and if the Subscriber answers the question correctly, the Subscriber's score will be 3. And this will be the score that will be considered for the winner selection for all the gratifications.

For winner selection first question time taken will not be considered.

14. The process of Winner selection for each category of prize, in accordance with the Winner selection process detailed in this Contest shall be the sole discretion of OnMobile and shall be witnessed by an independent third party auditor ("**Independent Auditor**") appointed by OnMobile who shall, after the selection of the Winners, certify such process. TTL shall be responsible only for the validation of the Subscribers details.
15. After the selection and validation of the Winners of all the gratifications under this Contest, the Winners will be contacted by OnMobile, by calling them for 3 (three) consecutive days on the number of the Winner(s) registered with TTL, and will be given further details as to how, when and where they can redeem their respective gratifications. For such purpose the Winner(s) will receive calls only from one of the numbers mentioned herein, i.e., 080-67186344 or 080-49080661. In the event the Winners do not answer the calls of OnMobile, an SMS will be sent to the MSISDN of the Winners, from the number 543218 intimating them regarding their winnings and providing them the details as to how, when and where they can collect their respective gratifications ("**Intimation**"). For the avoidance of doubt, Intimation shall be on such date on which the respective Winners are contacted by OnMobile regarding their winnings under the Contest, either by way of voice calls or SMS detailed above.

The Winners agree that there shall be no liability on OnMobile or TTL in the event the Winners

Without prejudice to the foregoing, any failure on the part of the Winner under this Contest to comply with directions issued by OnMobile or TTL shall entitle OnMobile, at its discretion, to cancel and forfeit the prize for the said Winner. The gratifications shall be delivered by Onmobile only after and subject to confirmation of an existing Permanent Account Number (“PAN”) of the Winner(s).

17. All costs and expenses for collecting the prize unless otherwise specified shall be borne solely by the Winners under this Contest and the prize shall not be transferable and no request shall be entertained by OnMobile or TTL for such transfer. In the event the gratifications cannot be delivered, when specified that they will be delivered, due to reasons beyond the control of OnMobile, the Winners shall collect them from the place specified by OnMobile.
18. All gratifications will be given after deducting various taxes, cess, license fees and charges, as applicable.
19. By entering the Contest, Subscriber confirm and waive the applicability of rules and regulations of the National Do Not Call Registry and You agree to receive promotional messages including without limitation daily updates of Your score and such other updates of the current Contest, promotional updates on the current Contest or/and any such contest/s as may be active for participation during the Contest Period. Also, the Subscribers may receive promotional updates from and at the sole discretion of the Partner, of the upcoming contest/s for 20 (twenty) days from the date of commencement of such upcoming contests. 20. All disputes must be addressed by the Subscriber in writing to OnMobile directly, and TTL shall not entertain any communication in this regard.
21. Where Gold Card is given to the Winner as a prize, it shall be given after deduction of such value equivalent to the amount of applicable taxes, including but not limited to,

Tax Deducted at Source (“TDS”) as applicable from time to time and applicable GST on the purchase of the Gold. The Winner will receive a TDS certificate in respect of the amount of TDS, and also a statement showing the value of the Gold received.

The Terms and Conditions of the Contest can be amended or varied from time to time or withdrawn and therefore, please visit the Website to keep Yourself updated and informed.
23. The value of the gratification offered as the Monthly gratification i.e. Iphone7 shall not exceed Rs.50000. In case the specified model, type of phone offered in this CONTEST is discontinued or not available during or after the CONTEST, the Organizer shall at its own discretion offer another phone of the similar value which may or may not be of the same brand. If the Winner wants the exact same model/type of the same brand mentioned as the Monthly Prize that he is eligible to in this CONTEST and if the price of the phone increase during or after the CONTEST or at the time of prize distribution/Winner announcement period, the Organizer will only pay the value of the phone that was during the launch of the CONTEST and the Winner has to pay or bear the extra amount.
