TERMS AND CONDITIONS FOR "Notty PIXY First Day First Show CONTEST"

A. ACCEPTANCE OF TERMS AND CONDITIONS

You acknowledge and agree that the following Terms of Use constitute a legally binding agreement (hereinafter the "<u>Agreement</u>") between you (hereinafter the "<u>User</u>" and/or "<u>You</u>") and Multi Screen Media Private Limited ("<u>MSM</u>"). You represent and warrant to MSM that you have read and understood the Terms and Conditions and the Privacy Policy (together the "<u>Terms</u>"), and agree to abide by the Terms and that you have the legal capacity to enter into this Agreement.

B. HOW TO PARTICIPATE

The Contest will commence from October 11, 2015 at 00:00 hours Indian Standard Time ("<u>IST</u>") and shall end on 23:59 hours IST on October 20, 2015 ("<u>Timelines</u>").
- 2. During Timelines, MSM shall ask the User to answer the question related to the movie 'The Last Witch Hunter' on the Notty Pixy Tab on Facebook ("*Contest Question*") on the Web-Page.
- 3. MSM shall not be responsible for any technical disruption and/or failure/ server problems and/ or any other difficulties of such nature, due to which the User is unable to upload the Entries (defined below) on the Web-Page and/or participate in the Contest.
- 4. Submissions made after the Timelines shall not be considered and shall be null and void.

- 2. MSM does not claim any ownership rights in any Entries and other materials which User uploads through the Web-Page.
- 3. User hereby expressly acknowledges and agrees that the User, and not MSM, is fully responsible for all Entries that the User uploads or otherwise makes available through the Web-Page.
- 4. The User acknowledges that the Entries uploaded to, or transmitted through the Web-Page may be protected by copyrights, trademarks, service marks, patents or other intellectual property rights and laws.  address.
- 3. This Contest is strictly governed by the laws of India including the Privacy Laws of India
- 4. The User must have attained the age of 18 years to participate in the Contest.
