Once a user calls 56505050, the system checks if the caller has already subscribed to the contest or not. The above applicable amount will only be charged post subscription through consent gateway i.e. second/final consent.

#### 5. Contest on Voice

- o If user presses any of the above options other than 1 & 5, then the appropriate prompt will be played according to the option selected and then the user will be taken back to the same menu of 5 options.
- o On max error, take user back to the contest.
- If user does not press 9 then he is taken to the 1st question.
- Each question has 2 answer options
- After every question and answer options, a beep prompt is played. Subscribers can answer the question only after the beep.
- Subscriber can press 1 for 1<sup>st</sup> Option or 2 for 2<sup>nd</sup> Option on the phone keypad to answer.
- For every right answer the user will get 1 point. There is no negative marking for a wrong answer.
- If caller gives an invalid input, then an appropriate prompt is played and the question and answer options will be repeated. On subsequent invalid input two more chances are given to the caller.
