TERMS AND CONDITIONS FOR THE "PAL DEKHO SMART BANO" CONTEST ON PAL

The "PAL DEKHO SMART BANO" Contest (herein after referred to as the "Contest") is hosted by Sony Pictures Networks India Private Limited ("Contest Organiser") in relation to the channel PAL ("Channel"), on such terms and conditions as stated hereunder ("Terms and Conditions"):

CONTEST DETAILS

The Contest Participants will also be required to register their Pin code number & Address for further communication. Contest Participants can submit their answer only once and any subsequent attempt for the same question shall be disallowed.
