By subscribing to the **contest** hereby agrees to the Terms and Conditions mentioned below and gives his/her consent to the terms and conditions that may be launched as part of this **contest.** For the purposes of these Terms and Conditions, wherever the context so requires "You" or "Your" shall mean any natural person who is a **SUPER CHALLENGE CONTEST SEASON 12** Participant.

A. All existing and new Subscribers of the contest hereby:

B. Eligibility for Contest subscription and winning gratification:

Each incorrect answer will be recorded as 0 points.
- 2. Post answering the 3 free questions of the day, participants can also play more questions which will be pay per question based. Participants will be charged Rs. 1 per question for playing PPQ (pay per question).
- 3. Subscription charges for the Service are Rs. 3 per day. The charged amount will not be refunded to Participants under any circumstances.

- 19. - 31. Aircel, IMI Mobile or any of their group entities or affiliates, their respective directors, officers, employees, agents, representatives, shall not be liable for any loss or damage whatsoever that may be suffered, or for any personal loss or injury that may be suffered (including loss of life), by Participant and/or any third party, directly or indirectly, by use or non-use of the prizes offered in Contest.
- 32. Aircel and/ or IMI Mobile may assign any or all of their rights under these Terms and Conditions to their affiliates without consent of the Participants.
- 33.
