1. Application form Deadline:

Please fill in the application form and submit before the 29th of December 2017. You may submit it electronically by scanning it and sending by email to sikkim.rpf2017@amail.com

2. A sample Video or Audio clip:

Please submit a sample audio or video clip of your band's performance which can be any song of your choice. The audio or video clip may not exceed more than 5 minutes in length. YouTube video clips or SoundCloud links are preferred.

3. Registration Fee:

A Registration Fee of Rs. 10,000/- needs to be deposited by the participating band at the time of form submission through Demand draft.

IMPORTANT DATES: The deadline for submitting the application form and sample video clip is **December 29, 2017**. Once your application and registration fee is received, an Invitation to perform at the "Red Panda International Open Rock Contest" will be sent to you via sms or email.

The date of the Contest is 16th, 17th and 18th January 2018.

VENUE: venue is Paljor Stadium, Gangtok, Sikkim and M.G. Marg, Gangtok, Sikkim. The time is from 4: 00 PM to 8:00 PM

PRIZE MONEY: The following are the prizes:

1st Prize: Rs. 6,00,000/-, trophy and certificates.

We, the undersigned band members/entrants, each hereby represent, warrant, acknowledge and agree that:

- We acknowledge that each and every entrant band member must sign this TERMS & CONDITIONS AGREEMENT AND UNDERTAKING. Only those entrants, who, as a named member of the band, have fully completed, signed and returned this TERMS & CONDITIONS AND UNDERTAKING (together with the Audition Files) by the Entry Deadline will be eligible to compete in the Contest and be eligible for any prize, including the opportunity to participate in the Finals of the Contest.
- 2. Once the Application Form, Terms & Conditions, and this Undertaking has been fully completed and signed by all band members, we shall submit them along with the band's Audition Files (collectively, the "Entry Materials") to the Organizer ("Organizer") by the Entry Deadline. All Entry Materials shall be completed and submitted together prior to the Entry Deadline.
- 3. Failure to i) fully complete the Application Form, ii) have the this **TERMS & CONDITIONS AGREEMENT AND UNDERTAKING** signed by all band members, iii) meet the requirements for the Audition Files, or iv) return the completed Application Form and Audition Files by the applicable Entry Deadline, will result in disqualification of the band and all of its band members. If Entry Materials do not comply with these Terms & Conditions in any manner, the entry may be disqualified at Organizer's sole and absolute discretion.
- 4. Our "Audition Files" must be audio recordings of at least one (1) original or cover song performed solely by band members who appear on this Application Form and Undertaking. The audio recording must be submitted in Audio CD or MP3 format. All recordings submitted will not be returned, so we will keep a copy of our audio recording.
- 5. My band has identified one (1) representative (the "Band Manager") on this Application Form and Undertaking who will be the contact person for the band in all matters related to this Contest and who shall also have authority to act on behalf of the band with respect to all aspects of this Contest. If my band is named as a potential Performing Band, Semi-Finalist, Finalist or Winner, and the Band Administrator cannot be reached by telephone within twenty-four (24) hours from the first notification attempt, then my band may be disqualified.
- 6. Although each member of my band must be 18 years of age or older to enter this Contest, if any band member is a minor, then the parent/legal guardian of such minor must sign this Entry Form and any other documents required on behalf of such minor.
- 7. All Performances of the band must be in agreement with the Organizers positive image. Without limitation, performances that are deemed by Organizer, in its sole and absolute discretion, to be or to contain profanity or explicit sexuality, or that is



harmful, threatening, abusive, harassing, tortuous, defamatory, vulgar, obscene, or libellous, or which encourages unlawful behaviour, or which is hateful, or which is racially, ethnically or otherwise offensive or objectionable, or which portrays the Organizer in a negative fashion, may be disqualified. THIS REQUIREMENT IS STRICTLY ENFORCED. NO PROFANITY MAY APPEAR OR BE HEARD ON ANY PERFORMANCES.

- 8. Application Form and Undertaking must be from an identifiable source. Any attempt to create a false identity, to impersonate any person or entity, or to make a false or misleading statement, or misrepresent an affiliation with any person or entity, may result in disqualification.
- 9. I agree that: a) The Organizers and its designees may use, copy, publish, videotape, broadcast, distribute and otherwise publicly display all elements of the Performances, the Video, and any other videos and recordings made of the Band's performances during the competition and during the Contest as well as each band member's name, address [city and state/province], biographical information, statements, voice, photograph and other likeness), in whole or in part, in any and all media either now or hereafter known, in perpetuity throughout the universe, solely in connection with advertising, promoting and conducting this Contest, without notification and without compensation of any kind to any entrant or any third party. The Organizer reserves all rights, including without limitation, the right to reproduce, alter, amend, edit, modify, crop and use the band's Performances, the Video, and any other videos and recordings made of the Band's performances during the competition in connection with advertising, promoting and conducting this Contest.
- 10. - 13. Each band member is solely responsible for payment of any and all applicable income or other taxes or fees due for or on account of any prize(s) or consideration that such band member receives as a result of this Contest.
- 14. I will not do anything or cause any third party to do anything which would manipulate or in any way influence the outcome of the Contest with the intent to deceive the public, including, but not limited to, tampering with any voting system or process. I agree that I will not participate in any such act or any other deceptive act with respect to the Contest, nor permit anyone to do so on our behalf. I agree that if anyone tries to induce me or my band to do any such act, I shall immediately notify the Organizers.
- 15. I hereby certify and represent that I have read the foregoing Application Form, undertaking and the Terms and Conditions of the Contest and fully understand the meaning and effect thereof, and intending to be legally bound, I hereby accept all of the terms and conditions contained herein.
