

TERMS AND CONDITIONS – BSNL GOLD CLUB CONTEST

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS CONTEST KNOWN AS “**BSNL GOLD CLUB CONTEST**”. BY PROCEEDING WITH PLAYING THE **BSNL GOLD CLUB CONTEST**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**Terms and Conditions**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE **BSNL GOLD CLUB CONTEST**.

Terms and Conditions:

1. “**BSNL GOLD CLUB CONTEST**” (hereinafter referred to as the “**Contest**”) is conceptualized, organized and conducted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India (“**OnMobile**” or “**Organizer**”) for active¹ pre-paid and post-paid category of Subscribers² (“**Subscriber(s)**”) of Bharat Sanchar Nigam Limited a company having its registered office at Bharat Sanchar Nigam Limited, (NS Branch), 10th Floor West Wing, Chandralok Building, Janpath, New Delhi - 110001 (hereinafter referred to as “**BSNL Mobile**”) and is valid during the period from 31st December 2017, 00:00:01 hrs to 24th March 2018, 23:59:59 hrs, both days inclusive, Organizer reserves the right to extend or shorten the Contest Period, as it deems fit, and any such change shall be published on the website, www.bsnl.contestzone.in (“**Website**”). The Terms and Conditions can be amended or varied from time to time or withdrawn and therefore, please visit the Website to keep Yourself (defined below) updated and informed.
2. The Contest is open for all Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below, who belong to the following BSNL Mobile telecom circles (“**Circles**”) of KERALA, KARNATAKA, ANDHRA PRADESH, CHANDIGARH (HARYANA, HIMACHAL PRADESH, PUNJAB, JAMMU & KASHMIR), RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, PUNE, MADHYA PRADESH & CHATTISGARH, GUJARAT, KOLKATA(WEST BENGAL, ASSAM, NORTH EAST), ORISSA, RANCHI by following the subscription process mentioned hereunder.

3. Eligibility

¹ An active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in the Contest or any other contests offered by the Organizer and BSNL Mobile jointly.

² Subscriber shall mean the rightful user of a BSNL Mobile connection, pre-paid or post-paid, in whose name the mobile phone number (MSISDN) is registered with the operator. In the event the number / connection is registered in the name of a company or firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Contest, receive the gratifications and accept the terms applicable for the Contest.

This Contest is open for subscription for all active prepaid and post-paid categories of BSNL Mobile Subscribers who fulfil the following criteria:

- Subscriber must be of or above 18 years of age;
- Subscriber must be a resident of any Circles(s) of India as listed under Clause 2 above;
- Subscriber must belong to any one of the Circles mentioned herein;
- Subscriber must be an active Subscriber of BSNL Mobile;
- Subscriber must not have been either convicted and / or prosecuted for commission of any criminal offence nor be of an unsound mind;
- Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship; and
- For Prepaid Subscribers – Subscribers must have a minimum requisite balance of Rs.7 to be able to subscribe to the Contest during the Contest Period.

For the purposes of these Terms and Conditions, wherever the context so requires “**You**” or “**Your**” shall mean any natural person who is a BSNL Subscriber. Also, by participating in this Contest, You:

- Agree to the Terms and Conditions mentioned below and give Your consent for the same;
- Agree that You are entering into this Contest as an independent party and nothing herein establishes an employer-employee relationship between You and BSNL Mobile or between You and OnMobile and You are acting voluntarily, using Your own time and resources to participate in this Contest, solely at Your own risk;
- Warrant that You have read, understood and agreed to conform to these Terms and Conditions;
- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and
- Warrant that prior to participating in the Contest, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.

The Contest will be available in the below mentioned languages:

Hindi, English, Kannada, Telugu, Malayalam, Tamil, Marathi, Gujarati, Bengali, Oriya.

A Subscriber by participating in the Contest, hereby agrees to the Terms and Conditions mentioned below and gives the Subscriber’s irrevocable consent to the process of selecting the winners (defined below) under this Contest as set out herein, and any appropriate changes that may be made to this Contest by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever.

Subscribers who are roaming outside their home Circle will not be able to subscribe and play the Contest.

Further, the Subscribers who participate in the Contest and are chosen as winners under each category of gratification in accordance with the winner selection process detailed in these Terms and Conditions will be the registered BSNL Mobile Subscribers of the winning mobile phone number and not merely the players using such mobile number (“**winner(s)**”). If the winner is not able to provide

sufficient evidence to show that the participant is the Subscriber of the mobile number, the Organizer reserves the right to award the gratification to the next eligible winners or to forfeit the gratification, at its sole discretion.

4. To Subscribe:

A Subscriber can subscribe to the Contest either by:

- Calling the Toll-free number 56505066.
- Dialing the Unstructured Supplementary Service Data ("**USSD**") String *505*66#
- Pressing 1 through Out Bound Dialer or In Bound Dialer followed by second consent.

If a Subscriber wants to unsubscribe from the Contest, then it can be done by calling the toll-free number 56505066.

5. Charging:

Once an MSISDN subscribes to the contest, the MSISDN will be charged Rs.7 every week for 4 minutes of usage. All Subscribers will be allowed to play the Contest only after being successfully charged Rs. 7 every week for the Contest. If the charging is successful, such Subscriber will get a confirmation SMS on the Subscriber's number registered with BSNL Mobile along with the rules, gratifications, Terms and Conditions URL, and the number on which Subscriber can call and participate in the Contest. The user can play the contest only for the duration of 4 minutes every week once they are successfully charged. If the charging is unsuccessful, the Subscriber will be sent an SMS on the Subscriber's number registered with BSNL Mobile, informing subscribers of such unsuccessful charging.

The above mentioned charges shall be deducted only after seeking Subscriber's double consent for participation in the Contest; immediately after the recharge is done by the Subscriber. The above applicable amount will only be charged post subscription through consent gateway i.e. second/final consent.

6. Contest on Voice

- Contest will be available on the toll-free number 56505066 for all Subscribers.
- The questions under this Contest shall be based on general information available to the public at large.
- The Subscriber can only play 3 questions per week which the Subscriber can play at any time during the week.
- The Subscriber can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer.
- After every question and answer options, a "beep" prompt will be played, post which Subscribers can answer the question.

- For every right answer the Subscriber will get 1 point. There is no negative marking for a wrong answer.

After every right or wrong answer, the Subscriber will be played an appropriate prompt followed by the Subscriber's updated score and the next question and option answers.

The time taken for answering a question is calculated from the time the question, answer and the "beep" prompts finish playing till the time the Subscriber provides an answer by pressing the relevant key.

- To listen to a question again Subscribers can press *
- If a Subscriber stops playing the Contest after answering the nth question on any day during the Contest Period, then when the Subscriber calls back on the toll-free number 56505066, the Subscriber will be played the (n+1)th question. If a Subscriber stops playing the Contest without answering the nth question then when the Subscriber calls back on the toll-free number 56505066, the Subscriber will be played the nth question which may be different from what the Subscriber received previously i.e., if a Subscriber listens to the 2nd question but drops the call without answering the 2nd question, then when the Subscriber calls back, the Subscriber will be played the 2nd question which may be different from what the Subscriber received previously.
- The Subscriber will be played the questions one after the other till the Subscriber finishes answering all the questions for the Contest.

- Winner of Valentines Special Gratification cannot win this gratification.

In case of a tie in the selection Weekly Gratifications, the winner will be selected which MSISDN has achieved the score 1st in point of time.

You acknowledge and agree that the amount mentioned in the Gold Card may not be fully utilized, subject to change in the rates and related antecedents to such Gold Card; and You hereby agree that You are not entitled to any refund or any claim for such unutilized amount. Any complaint or claim shall not be entertained with respect to such unutilized amount. You hereby confirm that You will provide necessary information and documents or otherwise pay any additional charges which are not included in the gratification money for using the Gold Card at the time of purchase and You shall not claim any reimbursements from the Organizer and/or BSNL. 8.2. All gratification will be given after deducting various taxes, license fees and charges as applicable. The gratifications shall be distributed only after and subject to confirmation of an existing Permanent Account Number ("**PAN**") of the Winner(s). All costs and expenses for collecting the gratification unless otherwise specified shall be borne solely by the Winners under this Contest and the gratifications shall not be transferable and no request shall be entertained by the Organizer for such transfer. By entering the Contest, You confirm and waive the applicability of rules and regulations of the National Do Not Call Registry and You agree to receive promotional messages on Your number registered with BSNL Mobile including without limitation daily updates of Your score under the Contest from the Organizer, as it may in its sole and absolute discretion decide.

18. Organizer, BSNL Mobile and their respective affiliates shall be entitled to use, in any manner, the details of the Subscribers including their names, photograph, number registered with BSNL Mobile, address etc. for their sales, marketing and promotional purposes, including the gratifications awarded to them, if any. By participating in the Contest, all Subscribers hereby agree to the same. Organizer may, at its discretion, choose not to disclose the identity of a Subscriber to other Subscribers unless expressly mentioned herein.

19. By participating in the Contest, Subscribers consent to the following information relating to them to be exchanged between BSNL Mobile, OnMobile and their concerned vendors and/or published or otherwise communicated to in any media that the Organizer may deem fit, for the purpose of Winner announcement: name, mobile phone number registered with BSNL Mobile, score and/or photograph. The Subscribers also consent to the information being shared by OnMobile with its affiliates and service providers and to the information being processed and stored in the servers of OnMobile or its service providers, inside or outside India.

20. Gratification(s) shall not be transferable. Cash alternative for the gratifications may or may not be given at the sole discretion of the Organizer. Organizer reserves the right to provide alternate models or brands or issue a Bank Gift Card or Bank Voucher (defined below) for the value of the gratification won under the Contest, after deducting applicable taxes, which may be redeemed by the Winner at stores accepting such Bank Gift Card or Bank Voucher.

22. A Bank Voucher or Bank Gift Card acts as a pre-filled card, in which the Winner's gratification amount, less TDS if applicable, is available and is given to the Winners under any category of gratifications under the Quiz, at the sole discretion of the Organizer. This Bank Voucher can be used and/or swiped as a credit or debit card in all outlets where debit or credit cards are accepted.
