RULES & REGULATIONS GOVERNING "LUKA CHUPI WITH JUHI"-

I. CONTEST DESCRIPTION:

- 6. **"Home Viewers**": Persons viewing the shows of the Channel during its initial exhibition on the Channel.

Questions on air

Daily Winner Selection

- 1. All valid correct entries received per day will be added to the Cluster which will be used for random selection of one winner per day.

Information

- 49. Company shall keep all the information collected from the Participants confidential for the purpose of inviting the Participants, if selected. Company shall ensure that the Participants are contacted only for the purpose present Program and all such information collected by the Company shall be destroyed if the Participants are not selected. Company shall not share the information so collected with any party, save and except for the purpose of the present Participants.
