FAMILY TIME WITH KAPIL SHARMA – RULES OF PARTICIPATION

- 5. The registrations shall commence from February 20, 2018 ("Registration Period").

- 7. SPN/ Production House shall in their sole discretion, select the Participants for the second level of selections after carrying out relevant check of the Entries by the Participant (s).
- 8. The selected / shortlisted participants will receive a call from SPN / production house and would need to furnish further details along with Family picture.
- 9. The selected Participant(s) will then receive a video call from SPN/ Production House on such date and time as will be pre-informed to the selected Participant(s). During the video call, Participant(s) will be required to ensure presence of all family members participating in the Show.
- 10. Selected Participant(s) will then receive an email confirmation stating the date of shoot, rehearsal date, etc.
- 11. SPN/ Production House shall be under no obligation to select all or any of the Participant (s) from the Entry(s) and shall have the absolute and sole discretion to select such Participant (s) as it deems fit for the purpose of the Show. By agreeing to the present Terms and Conditions, Participant (s) waive their right to object to the selection process of SPN/ Production House or file a claim against SPN/ Production House.
- 12. SPN/Production House shall be entitled to verify the Entry(s) and or seek for such proof from the Participant(s) as shall be necessary in respect of the entries at any time as SPN/Production House shall deem necessary. This includes verification of family members. Participants will be asked to furnish documents verifying the same. In case of any inconsistencies, SPN/ Production House reserves the right to disqualify such Participant(s).

- 13. SPN shall not be liable for any costs including accommodation cost, transportation cost incurred by the shortlisted candidates (including NRI/OIC/POI candidates, if any) to reach the venue for the shoot.
- 14. SPN/Production House has the right at any time to require proof of identity and/or eligibility. Any failure to provide such proof within a reasonable time could result in disqualification from the Show. All personal details and information requested by and supplied to SPN/Production House by Participant(s) must be truthful, accurate and in no way misleading. SPN/Production House reserves the right to disqualify any Participant(s) from the Show in its sole discretion, should the Participant(s) at any stage supply untruthful, inaccurate or misleading personal details and/or information.

- 3. Participant(s) should ensure the accuracy of the information provided by them at the time of entering the Show.
- 4. SPN shall make a maximum of 2 (two) attempts, each attempt being within 1 (one) hour of each other, to contact the Participant(s) via the mobile number provided by the Participant(s) at the time of registration. SPN shall not be held liable despite SPN's best efforts, in the event the provided mobile number is unreachable due to the following reasons including but not limited to: 1) Mobile number provided by the Participant(s) is incorrect. 2) Mobile number belongs to a person other than the Participant(s) 3) Any other reason the Participant(s) cannot be contacted.
- 5. After the Participant is shortlisted for the Show, he/she may be required to sign certain documents provided by SPN, as the case may be, which shall release SPN of all liability. Failure to complete and sign any documents requested by SPN may result in disqualification of the Participant. All decisions of SPN are final in this regard.

SPN abhors such practices and disclaims all responsibility for the same. SPN shall not be liable to any participant for any amount paid in this regard.
- 16. Under no circumstance, unless due to wilful misconduct or gross negligence, shall SPN and/or their directors, employees, officers, affiliates or subsidiaries, be liable to the Participant(s) and/or any third party for any lost profits or lost opportunity, indirect, special, consequential, incidental, or punitive damages whatsoever.
