

RULES OF THE COMPETITION

CCAL Constitutional Law Quiz 2015

The **Centre for Constitutional and Administrative Law** of Gujarat National Law University welcomes you to its First Constitutional Law Quiz competition, scheduled to be held on Thursday **26 November**. This Quiz Competition is organised to celebrate 125th Birth Anniversary of Dr. B. R. Ambedkar. The rules for the event are as follows:

1. INTERPRETATION

- 1.1. 'Quiz' shall mean the CCAL Constitutional Law Quiz 2015 being organized by the Centre of Constitutional and Administrative Law, Gujarat National Law University.
- 1.2. 'Organizing Committee' shall refer to the Organizing Committee involved in management of the current event.
- 1.3. 'Participant' shall refer to the students participating in the said competition.
- 1.4. 'Sudden Death' shall refer to the case where the team to give out the first incorrect answers in the Elimination Round shall be eliminated

2. GENERAL RULES

- 2.1. Only team entries are eligible. Schools may send any number of teams; subject to rule 3.7.
- 2.2. A team shall comprise of only two students.
- 2.3. **Eligibility:** Bona fide students pursuing their Higher Secondary Education from recognized schools of Ahmedabad and Gandhinagar are eligible to participate.
- 2.4. **Dress Code:** The official Dress Code for the Competition is the school uniform of their respective schools.
- 2.5. Language of quiz shall be English.
- 2.6. The decision of the quiz master will be final and binding.
- 2.7. The participants are not allowed to use mobiles or any other electronic devices during testing hours.
- 2.8. **Important Note:** It is advisable that the team shall be accompanied by one of their school teacher.
- 2.9. Replacement of any participant of a team is not allowed after registration.

- 2.10. All the writing material shall be provided by the organizing committee.

3. ELIMINATION ROUND

- 3.1. Each team shall answer 25 objective type questions.
- 3.2. The questions shall be projected through a PowerPoint Presentation in an Audio Visual format.
- 3.3. There shall be no negative marking.
- 3.4. Each team has to write down the answers on the sheet provided by the organizing committee.
- 3.5. In case of a tie, questions marked with a star shall be used as tie breakers. If the tie is not resolved, sudden death shall be used.
- 3.6. The top 6 teams shall qualify to the final round.
- 3.7. In case more than two teams from the same school qualifies for the final round, the top two teams from the school shall be allowed to go in the finals.

4. FINAL ROUND

- 4.1. The final round shall consist of four rounds which will be both written and oral rounds.
- 4.2. The questions shall be projected through a PowerPoint Presentation in an Audio Visual format.
- 4.3. First round shall be the written round for which a sheet will be provided by the organizing committee to write the answer.
- 4.4. First round will be having negative marking.
- 4.5. Second and third rounds will be comprising of direct questions which shall have an opportunity for teams to answer out of line by raising their hands. Each correct answer will ensure positive points. Upon the delivery of an incorrect answer points shall be deducted from the team's total tally.
- 4.6. If a team is unable to answer a question, it may choose to pass it on to the next team.
- 4.7. Discussion within the team is allowed, but the students must refrain from prompting answers for the other teams.
- 4.8. The last round will be a Mega Connect Round. It shall have a number of individual questions which when put together will give out a common theme. Extra points shall be awarded for answering the theme.

5. MISCELLANEOUS

All matters pertaining to the eligibility of participants, format, evaluation and awarding of prizes is within the sole and absolute discretion of the organizing committee of the Centre for Constitutional and Administrative Law, GNLU.
