Terms and Conditions - Participation in SAB FAMILY FUNATHON

The event titled "SAB FAMILY FUNATHON" (hereinafter referred to as "Event") is organised by Multi Screen Media Private Limited and/or its affiliates ("MSM") on the terms and conditions stated herein under ("T&Cs"/ "Terms and Conditions"):

The Event will be a 3(three) kilometre run held on 29th November, 2015 at Lucknow at KD Singh Babu Stadium, Lucknow as may be decided by MSM at its sole discretion.

Your participation in the Event signifies your assent to these Terms and Conditions which includes without limitation your assent to the waiver on behalf of the You and your Family (defined below). Any reference to you ("You/Participant") shall wherever the context requires also mean to include Participant's other family members i.e. a minimum of (1) one or maximum of five (5) family members (excluding the Participant). For being able to participate in the Event the Participant in addition to himself/herself is required to nominate minimum (1) one or maximum of five (5) family members of his/her family.(hereinafter collectively referred to as "Family"). For the sake of clarity, MSM shall only consider a total of either a two (2) or six (6) member family (including the Participant) for the purpose of participating in the Event at MSM's sole discretion. The Participant registering on behalf of the Family shall be responsible for ensuring that all the family members abide by and are bound by these Terms and Conditions.

(1) Age Criteria-

- Person(s) of age group 13(thirteen) years and above can participate for the Event. However participation of person(s) below 18 years of age shall be valid, only after being registered by their respective Parent or Guardian.
- Participants above 70 (seventy) years of age will not be allowed to participate in the Event.

- (4) **Registration confirmation:** Post close of registrations, email and/or SMS confirmations will be sent to all the confirmed Participants who have given their valid email id and valid cell phone number in the Registration form.
- (5) Collection of Running Bibs-. Participants can collect the Bibs at the race venue KD Singh Babu Stadium on the Race day i.e. 29th November, 2015 at the reporting time. Participants to note that merely by registering for the Event by filling in the Registration Forms will not entitle such Participant(s) to participate in the Event. Participants have to mandatorily collect their Running Bibs in order to be eligible to participate in the Event.

(6) On what grounds can Participant's Registration be rejected or declared invalid?

Participant's Registration can be rejected on any of the grounds listed below.

- 1. Incomplete form submitted,
- 2. Applicant is underage/over age for the race chosen,
- 3. More than one entry form received from the same applicant,
- 4. Required documents not attached/submitted/submitted documents not valid,
- 5. Running places are full,
- 6. Any other reason.

Terms and Conditions governing the Event:

The Participant agrees to be bound by these Terms and Conditions (which includes the waiver appended below).

a. However participation of person(s) below 18 years of age shall be valid, only after being registered by their respective Parent or Guardian. Family members of the Participant who are below 18 years of age shall be eligible to participate in the Event voluntarily on their own behalf subject to the consent of their natural guardian/s and without being under any compulsion or duress.

- b. The Participant acknowledges that participation in and training for the Event involves potentially dangerous physical activity and inherent risks and dangers of accidents, personal injury (including death) and loss or damage to property. - i. For the avoidance of doubt, MSM will not be liable to the Participant in contract, tort (including, without limitation, negligence) or otherwise in connection with the Event for loss of revenues, profits, contracts,

- business or anticipated savings or loss of data); or goodwill or reputation; or any special or indirect or consequential losses; for any personal injury to or death of the Participant.
- j. Participant's running number bib is not transferable to any other person under any circumstance. Participants found to have interchanged their running number bib with another individual, will be disqualified from the Event.
- k. MSM reserves the right to disqualify or exclude any person from competition who gives incorrect personal data/details on the Registration form, who has been banned from competition under Indian jurisdiction, or who is suspected of having taken banned substances.
- 1. Participants are not allowed to run with babies or children who are under aged.
- m. In order to ensure the re-opening of roads to normal traffic by timings MSM will designate cut off times at specified locations. Participants failing to reach these specific locations within times specified must stick to the footpath in order to complete their race.
- n. Only those confirmed Participants wearing the correct running bibs will be allowed on the route. Any person found wearing the incorrect bib or no bib will be disqualified and removed by the Event security.
- o. Further, every Participant must wear his/her running bib on the front of the vest worn. Any mutilation, fold, alteration or damage to the bib will amount to disqualification of the Participant from the Event.
- p. MSM reserves the right to stop any Participant from participating who is found medically unfit to continue in the opinion of the medical personnel.
- q. For security reasons, Participants are requested to come without any baggage. It is strongly recommended that Participants do not carry valuables like mobile phone, camera, jewellery, watch, electronic gadgets etc. MSM will not responsible for any loss of baggage and belongings.
- r. Participants are requested to cooperate with the police and security personnel deputed at the Event venue and on route. Participants/supporters are liable to random checking on race day.
- s. Photographs taken of Participants during the Event are the property of MSM and will be used for promotional purposes.
- t. 1.
