



RULES & REGULATIONS

1. AIM & PURPOSE:

- **1.1.** The Surana & Surana International Technology Law Moot has been conceived with the aim of creating awareness of the latest technological developments and providing a platform for development of skills required for addressing the techno-legal issues arising out of it.
- **1.2.** The judgment¹ writing competition will be a part of Surana & Surana International Technology Law Moot Court Competition with the following principles and purposes:
 - **¶ 1.** A Judgment has a social and civic function besides the primary principle of promoting Rule of Law & upholding justice.
 - ¶ 2. To achieve the above, it must "have clarity of thought, explain decision to the parties, communicate reasons for the decision to public and provide reason for an appeal court to consider".²
 - **¶ 3.** To develop a well-balanced judicious mind.
 - **¶ 4.** Prevent abuse of legal process

2. VENUE, DATE & SUBJECT MATTER:

The 14th Surana & Surana International Technology Law Moot Court Competition, 2015 shall be held from **August 21, 2015 – August 23, 2015** at Symbiosis Law School, Pune. This year's case is set on issues relating to International Technology Agreement, Nanotechnology, its medical exploitation and technology transfer.

3. ELIGIBILITY:

The competition is open only for students who are pursuing LL.B (three year or five year programme) during the current academic year. To augment technology related research a team have the option of having only one student member (must be an undergraduate) from technology / science discipline (other than law), from any institution approved by the HOD or the Head of the Institution.

4. <u>The Competition Shall Be In English Language.</u>

The official and authentic decision of a court of justice upon the respective rights and claims of the parties to an action or suit therein litigated and submitted to its determination(Black's law Dictionary)

5. <u>TEAM COMPOSITION:</u>

- **5.1.** The team should consist of three members (including the technology/science student member) i.e. two speakers and one researcher. A team may also consist of only two speakers with the express permission of the Administrators.
- **5.2.** The researcher shall not be allowed to speak except under special circumstances and only with the express permission of the Administrators.
- **5.3.** The identity of the team must not be disclosed to the judges. Any such disclosure shall lead to disqualification under Rule 12.

6. **REGISTRATION:**

- 6.1. There will be a two-tier Registration Procedure. The participating colleges shall have to register both with 'Surana& Surana International Attorneys' and 'Symbiosis Law School, Pune'. <u>The registration opens on May 14, 2015 (Thursday).</u>
- 6.2. Registration with Surana & Surana International Attorneys
 - 6.2.1. The teams must register online at <u>www.mootsite.com</u> / <u>www.moot.in</u> by July 18, 2015 (Saturday).
 - **6.2.2.** Online registrations shall be open from <u>May 14, 2015</u>. Participants will receive an acknowledgement cum approval as confirmation of their online registration & participation within a week.
 - **6.2.3.** A scanned copy of the letter from the participating college / institution / university duly signed by any one of the following authorities: Faculty-incharge for Moot Court Cell/Society/Association, Registrar, Principal, Dean, Director, Chancellor or Vice-Chancellor. The authority must confirm the Names and Year/Semester of the participants who are representing the college / institution / university for the moot competition which will have to be attached during the online registration process (The approval letter shall be printed on the letterhead of the participating institution / college /university alternatively you may use the registration form itself as appended at the end)
 - **6.2.4.** Registrations without the scanned copy of the approval letter from the college/institution/ university or duly attested registration form will not be valid.
 - **6.2.5.** Once the online registration is done, no change in names will be accepted. However, in exceptional circumstances if a change in name is inevitable a fresh online registration have to be made along with a scanned copy of the approval letter from the college/institution/ university or duly attested registration form clearly explaining the reasons for the change and with authorized signature& seal of the college/ institution / university.





6.3. Registration with Symbiosis Law School, Pune

- 6.3.1. The participating colleges are required to email the Soft Copy of the Registration Form annexed here in the rules by July 18, 2015 (Saturday) to <u>surana.moot@symlaw.ac.in</u>
- **6.3.2.** Participants must carry the hard copy with themselves when they arrive for the competition.
- **6.4.** No change in the names of the participants shall be permitted after the receipt of the Registration Form, except at the sole discretion of the Administrators.

7. <u>Memorials:</u>

- **7.1.** Each team must prepare memorials from both parties to the dispute. The hard copies must be exact print outs of the soft copies. Non -compliance with this rule would entail disqualification under Rule 12.
- **7.2.** All participating teams must submit a soft copy of their memorials from both the sides on or before <u>August 02, 2015 (Sunday</u>) by <u>09:00 p.m. IST.</u> Non -compliance with the rule will attract penalty under Rule 12.
- **7.3.** The soft copies of the memorials must be emailed to <u>surana.moot@symlaw.ac.in</u> with a copy marked to <u>mootcourt@lawindia.com</u> and the subject of the mail marked as "Memorial Submission by Team Code _____ for 14th Surana & Surana International Technology Moot Court Competition, 2015."

7.4. Teams must send **3 Hard Copies** of the memorials [Total 06 copies] which should reach Symbiosis Law School, Pune by **August 05, 2015.**Non -compliance with the rule will attract penalty under Rule 12. The remaining **3 Hard Copies** of the memorials (Total 06 copies) should be submitted during orientation on **August 21, 2015.**

7.5. Postal Address for the submission of Hard Copy of the memorials is as follows:

7.6. The *soft copy of the memorial* for each side shall be a **single file** and in **MS-Word**. It shall correspond with hard copy of the memorial. There should only be two word documents (All parts of each memorial must be in a single document), one for Claimant and the other for the Respondent. (Separate Ancillary Pages and Arguments in Detail are not allowed).





- 7.7. Each Memorial should not exceed more than 40 A4 pages. The "Arguments in *Detail*" and the "*Prayer*" should not exceed more than 25 A4 pages.
- **7.8.** The memorials <u>should not contain the name of the participating college</u> in any part thereof. Also, no logo or any mark of identification should be made in the memorials. Non-compliance with this rule will lead to immediate disqualification.
- 7.9. The Cover Page of the Memorial must have the following color scheme:Blue: Claimant Cover PageRed: Respondent Cover Page
- **7.10.** The Cover Page of each Written Submission must contain the following information:
 - a) The Team Code should be mentioned in the upper right-hand corner. For instance, if the Team Code of the Participating Team is ST_150; the Memorial Code on behalf of Claimant would be "ST_150_A" and for the Respondent would be "ST_150_D".
 - **b)** The year of the Competition
 - c) The name of the Case
 - d) The party for which the Written Submission has been prepared.
 - e) Name of the forum resolving the dispute.

7.11. The memorials must contain the following:

- a) Cover Page;
- **b)** Table of contents;
- c) List of Abbreviations;
- d) Index of Authorities;
- e) Statement of Jurisdiction;
- f) Statement of Facts;
- g) Issues Presented;
- **h)** Summary of Arguments;
- i) Arguments in detail;
- j) Prayer

Arguments Advanced

Ancillary Pages

- 7.12. The Memorial shall be formatted according to the following specifications:
 - **¶ 1.** Typed on standard *A4 size page*.





- **¶ 2.** *Font type:* Times New Roman.
- **¶ 3.** Font size for body text: 12; the text of the written submission must have 1.5 (1.5 lines) spacing. Font size for the *cover page* may be 14 or 12.
- ¶ 4. Font size for footnotes: 10; text of footnotes should be single-spaced (1.0).
- ¶ 5. *Margin:* 1 inch margin on each side of the A4 size page.
- **¶ 6.** Quotations of sources of 50 words or more in any part of the memorial should be block quoted, indented and must be in *italics*.
- ¶ 7. The participating teams should include Header and Footer in their memorials to the effect that the Header should mention the full Name of Competition and the Footer should mention the side on whose behalf memorial is submitted along with Page Number at Bottom Center of the Page.
- **7.13.** The footnotes must follow the 19th Bluebook format of citation.
- **7.14.** Since this moot is an environment friendly moot, use of plastic binding is prohibited. Memorials should be stapled by not more than 5 staples on the left hand side or stitched by cotton thread. Teams are advised not to use spiral or comb binding.
- **7.15.** The Memorial must not contain any Annexure/Photographs/Sketches/ Exhibits/Affidavits etc.
- **7.16.** The memorials will carry a maximum of 100 marks each. The marks scored by the teams will be added only to the two preliminary rounds.
- 7.17. <u>Parameters for judging the memorials are:</u>
 - ¶ 1. Logical development of ideas,
 - ¶ 2. Novelty in analysis and arguments,
 - ¶ 3. Understanding pertinent legal issues,
 - ¶ 4. Clear, concise and unambiguous writing style,
 - ¶ 5. Integration of facts into legal argument,
 - ¶ 6. Understanding of strengths and weaknesses of case,
 - ¶ 7. Discussion of viable alternative arguments,
 - **¶ 8.** Proper use of citations and citation form,
 - ¶ 9. Effective use of authority to support arguments,
 - ¶ 10. Ability to distinguish adverse cases &
 - ¶ 11. Neatness, legibility and formatting.





8. <u>ROUNDS:</u>

- 8.1. Number of Rounds:
 - 8.1.1. Two Preliminary Rounds
 - 8.1.2. Octa-Final Rounds (if no. of participating teams exceed 32)
 - **8.1.3.** Quarter Final Rounds (if no. of participating teams exceed 16)
 - 8.1.4. Semi Final Rounds &
 - 8.1.5. Final

8.2. There will be an Orientation Program for all the participants on *August 21, 2015* (*Friday*) followed by a draw of lots & exchange of memorials. Oral Team Codes and Sides for Pleadings will be allotted.

8.3. Preliminary Round

- **¶ 1.** There will be two preliminary rounds of arguments per team, one on behalf of Applicant & another on behalf of Respondent, respectively.
- **¶ 2.** No team will face each other more than once in the Preliminary Rounds.
- **¶ 3.** Each team will face a different Bench in their Second Round of Arguments.
- ¶ 4. Preliminary / Octa-finals / Quarter-finals will be held on August 22, 2015 (Saturday), and the top sixteen / eight teams, will qualify for the Octa-finals / Quarter-finals as mentioned above.
- ¶ 5. Top sixteen / eight teams will be selected on the basis of rounds won (two wins). In case of a tie, the team with the highest Preliminary Round Score will qualify. (The team with highest scores in Preliminary Round will advance to Octa-Finals / Quarter-Finals).

8.4. Octa-Final Rounds / Quarter-Final Rounds / Semi-Final Round / Final Round:

8.4.1. The Octa-Final Rounds / Quarter-Final Rounds / Semi-Final Rounds are Knockout Rounds. Lots / power matching will decide the side of the arguments / matching teams in Octa – Final Rounds, Quarter – Final Rounds, Semi – Final Rounds & Final. The top four winning teams will qualify for Semi – Final Rounds to be held on 23rd August, 2015 (Sunday). Winners of Semi Final Round will qualify for the Final Round to be held on 23rd August, 2015 (Sunday).

8.5. The dress code shall be advocate's attire during the competition rounds i.e. Black and White Combination including a Black Blazer, Tie (for boys) and Formal shoes.

8.6. The oral arguments need not be confined to the issues presented in the memorials.





8.7. Results

8.7.1. Results will be announced within 30 minutes after the completion of the Preliminary / Octa / Quarter / Semi - Final Rounds. The Final result and the winners of the various categories will be announced only during the valediction / prize distribution ceremony.

9. ORAL PLEADINGS:

- 9.1 The oral rounds will commence on August 22, 2015 (Saturday).
- **9.2** There will be two Elimination Rounds(Preliminary Rounds) i.e. Round-I and Round -II, followed by Octa-Final Rounds / Quarter-Final Rounds, Semi-Final Rounds and Final Round.

9.3 Preliminary, Octa Final & Quarter Final

- **¶ 1.** Each team will get a total of 30 minutes to present their case. This time will include rebuttal and sur-rebuttal, both being compulsory.
- **¶ 2.** The division of time is at the discretion of the team members, subject to a maximum of 15 minutes per speaker. Division of time shall be informed to the court officer before arguments.
- **¶ 3.** The team will be given 2 minutes to make the Rebuttal or the Sur-Rebuttal as the case maybe.
- **¶ 4.** Participants should take note that Rebuttals or Sur-Rebuttals can be made by one speaker only.
- \P 5. The researcher shall sit with the speaker at the time of orals.

9.4 Semi Final & Final Round

- **1.** Each team will be given 45 minutes to present their oral arguments. This time will include rebuttal and sur-rebuttal, both being compulsory.
- 2. The division of time is at the discretion of the team members, subject to a maximum of 25 minutes per speaker. Division of time should be informed to the court officer before arguments.
- **3.** The team will be given 2 minutes to make the Rebuttal or the Sur-Rebuttal as the case maybe.
- **4.** Participants should take note that Rebuttals or Sur-Rebuttals can be made by one speaker only.
- 5. The researcher shall sit with the speaker at the time of orals.





10. <u>ANONYMITY</u>

Participants may introduce themselves to the court by their individual code. However, the team's college name should not be mentioned at any time. Further, all team members, coaches, advisors and observers shall refrain from identifying a team's school/college at any time and in any manner, including, but not limited to, wearing and carrying any identifying items, such as badges, blazers, or pins or carrying identifying material (such as a books with a college logo, or college seal)

11. MARKING CRITERIA FOR ORAL PLEADINGS:

- 11.1. The judges will assess the performance under the following heads-
 - ¶ 1. Knowledge of the facts,
 - **¶ 2.** Proper and articulate analysis of the issues arising out of the facts,
 - **¶ 3.** Understanding of the international / national legal principles directly applicable to the issues,
 - ¶ 4. Ability to explain clearly international / national legal principles in general adherence to the time allotted,
 - ¶ 5. Knowledge and use of legal sources: treaties, custom, general principles of international / national laws,
 - ¶ 6. Ingenuity (ability to argue by analogy from related aspects of international/ national law,
 - ¶ 7. Logic and reasoning,
 - **¶ 8.** Organization and clarity,
 - ¶ 9. Persuasiveness &
 - ¶ **10.** Deference to the court.
- **11.2.** For the duration of **Preliminary Round**, the memorial scores will be added to the score of oral rounds.
- **11.3.** Memorial scores will not be added to the overall scores in any of the Knockout Rounds (Octa-Final Rounds, Quarter-Final Rounds, Semi-Final Rounds and Final).

12. PENALTIES & DISQUALIFICATION CLAUSE:

Notwithstanding anything written as a part of the abovementioned rules, the following penalties shall be levied on the participants:-

A. The hard copies must be exact print outs of the soft copies. Non-compliance with this rule would entail disqualification.





- **B.** Soft copy of Memorials submitted after the stipulated time will attract a **penalty** of one mark for each hour of delay (on August 02, 2015 by 09:00 p.m. IST) and **two marks for each subsequent day** of delay, subject to prior notification and approval.
- C. Hard copy of Memorials submitted after August 05, 2015 will attract a penalty of **one mark per side for each day** of delay subject to prior notification and approval.
- **D.** Memorials exceeding the length of 40 A4 Pages stipulated in **Rule 7.7**shall be subject to deduction of marks.
- E. Non-compliance with the rules mentioned in Rule 7.2 7.15 will attract deduction of marks.
- **F.** Team will be disqualified if they reveal the name of their College/University/Law School i.e. Non-Compliance with **Rule 10** will result in Disqualification of the participating college from the Competition.
- **G.** Non-Compliance with **Rule 20** will lead to disqualification of the participating college from the Competition i.e. if team is found guilty of Scouting.
- **H.** Non-Adherence to any of the Rules of the Competition or any Rules of the Organising College and misbehaviour or unlawful conduct by the participating College/University/Law School will result in disqualification of the team from the Competition.

13. ACCOMMODATION AND BOARDING:

- 13.1. The last date for sending the Travel Plan to Symbiosis Law School, Pune is August 10, 2015.
- **13.2.** The Administrator will provide accommodation and boarding only during the dates of the competition.
- **13.3.** The Administrator will not provide any travel allowances but may take care of local conveyance exception to Rule 14.
- **13.4.** The Local teams shall not be provided with accommodation or travel assistance.
- **13.5.** Furthermore, the organizers are only responsible for picking up teams from the place of arrival. Conveyance shall be provided from the accommodation to the venue during the competition. The organizers shall not be responsible for providing conveyance after the Moot and for the departure of the participants.
- **13.6.** Accommodation to the participants shall be provided from *August 21, 2015, 12:00* noon to August 24, 2015, 12:00 noon only.





13.7. The organizers shall be providing separate accommodation for boys and girls.

- **13.8.** Participants desiring to reach early or depart late must make their own arrangement for stay earlier/beyond the time stipulated above and should inform the Administrators by **August 15, 2015**.
- **13.9.** The teams would be responsible for any damage at the place of stay and would have to compensate for the same. The Administrators will not be responsible.

14. <u>Reimbursement of Travel</u>

- **14.1.** The teams or their respective sponsoring institution shall meet their travelling expenses.
- 14.2. In order to encourage law schools from remote parts of India, Surana & Surana Public Charitable Trust contemplates reimbursing sleeper class Non A/c train fare (to & fro) to three members of teams participating from remote areas of Arunachal Pradesh, Assam, Bihar, Chattisgarh, Haryana, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Madhya Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Orissa, Tripura and Uttaranchal. The head of the institutions must forward applications in advance to The Administration Officer, Surana & Surana Public Charitable Trust, International Law Centre, 61 63 Dr. Radhakrishnan Salai, Mylapore, Chennai 600 004.
- 14.3. The teams must first participate and then claim the reimbursement.

18. <u>Rules Regarding The Judgment Writing Competition:</u>

- ¶ 1. Title: The competition will be called "Surana & Surana International Judgment Writing Competition on Technology Law". This judgment writing competition will be a part of Surana & Surana International Technology Law Moot Competition.
- **¶ 2. Rules:** Besides the rules given below all relevant rules of the International Technology Law Moot rules are applicable.
- **¶ 3.** Eligibility: The teams participating in the Surana & Surana International Technology Law Moot Court Competition.
- **¶ 4.** Structure: The structure of the judgment will reflect the forum / court in which the moot case is set and argued.
- ¶ 5. Submission:
 - a) The judgment should be written and submitted in .doc or .docx format on the last day of the international moot court competition, i.e. on 23rd August 2015.
 - **b)** Participation in judgment writing competition is compulsory for all the teams and researcher from each team shall represent the team in the competition.
- **¶ 6.** Evaluation criteria (based on application of principle, objective and knowledge of technology)
 - a) Format (All the steps of a judgment)
 - **b)** Language and style (lucid expressions, brevity not at cost of clarity)
 - c) Facts in brief
 - d) Issues
 - e) Application of law
 - f) Ratio Decidendi
 - **g)** Justification of decision
 - **h)** Operative order
 - i) Obiter dicta (the judge's mind)
 - j) Creative interpretation of citations, facts, law and innovative approach.





¶ 7. Prize and Certificates:

- a) Winner: Rs. 25,000/-
- b) Runner-Up: Rs. 15,000/-
- c) 3rd and 4th best will be awarded certificates.
- **d)** All the participants who have submitted the judgments would get participation certificates. The winners (winner / runner up) would be awarded respective plaque and individual certificates.
- **¶ 8.** Jury: The results announced by the eminent juries will be final and no further representation will be entertained in this regard

¶ 9. Results:

- a) Will be communicated by mail/email/posting on the websites of SLS: www.symlaw.ac.in/www.moot.in.
- **b)** Winning entries will be uploaded www.moot.in / and in website of SLS, Pune.
- c) Prize cheques and certificates will be sent by post to the respective winners.

19. <u>Copyright:</u>

- **19.1.** The copyright over the memorials and the judgment entries submitted for participation in the competition is assigned by participants and shall also vest completely and fully in Symbiosis Law School, Pune and Surana & Surana International Attorneys Chennai, in lieu of waiver of competition registration fees. The participants shall certify in writing the originality of materials contained therein and shall be responsible for any claim or dispute arising out of the further use and exhibition of these materials.
- **19.2.** Further use and exhibition of these materials, electronically or otherwise, shall be the exclusive right of Surana & Surana International Attorneys, Chennai and Symbiosis Law School, Pune and they shall not be responsible for any liability to any person for any loss caused by errors or omissions in this collection of information, or for the accuracy, completeness, or adequacy of the information contained in these materials.
- **19.3.** Distribution of these materials on affiliated websites such as www.mootsite.com, www.moot.in does not constitute consent to any use of this material for commercial redistribution either via the Internet or using some other form of hypertext distribution. Links to the collection or individual pages in it are welcome.

20. SCOUTING:

No member of any team will be permitted to hear the arguments in any court room in which that team is not one of the contesting teams whilst that team is still in the competition. The Administrator shall take strict action, including expulsion from the competition, against any team found to be scouting through a team member or through any other means.





21. ADMINISTRATOR AND DISPUTE RESOLUTION AUTHORITY:

22. Administrators' Powers:

- **20.1.** All Participants are expected to maintain decorum in the Court during the competition and are expected to conduct themselves in a manner befitting the legal profession. The Administrators reserve the right to take appropriate action for any unethical, unprofessional and immoral conduct.
- **20.2.** The Administrators' decision as regards the interpretation of rules or any other matter related to the competition will be final and binding.
- **20.3.** If there is any situation which is not contemplated in the rules, the Administrators' decision on the same shall be final and binding.
- **20.4.** The Administrators reserve the right to vary, alter, modify, or repeal any of the above rules without any prior notification, if so required and as they may deem appropriate.
