

Terms and Conditions for SAB Sahib Biwi aur Boss Dekho... Sona Jeeto Contest

The following terms and conditions (“T&Cs”/ “**Terms and Conditions**”) shall be applicable to Sony Pictures Networks India Private Limited (“SPN”) formerly known as Multi Screen Media Private Limited owned television channel ‘SAB’ (“**Channel**”) for the activity conducted by SPN (“**Activity**”) which shall function in accordance with the Specific T&C’s at end of this T&C and the contest shall be termed as follows:

The T&Cs shall be in two parts (a) Specific T&Cs for each Contest and Basic T&Cs for the Contest.

“GeneralT&Cs”:

Following are the terms that shall be applicable to the Activity:

1. The Activity is open only to Indian citizens, residing in India. Citizens and/or residents of countries other than India are not eligible to participate. Citizens and/or residents of countries other than India residing in India are not eligible to participate.

(All persons fulfilling conditions mentioned in section 1 & 2 shall be hereinafter referred to as “*Participants*”)
