

## **BharatNet Logo Contest Terms & Conditions**

- The contest will remain open up to **15<sup>th</sup> May, 2018 till 2300 Hrs.**
- The Contest is open to all Indians from India or abroad. Registered Organizations under relevant Indian laws are also eligible to participate.
- Only one entry shall be permitted per individual or organization.
- All entries must be submitted to the creative corner section of [www.mygov.in](http://www.mygov.in). Entries submitted through any other medium/ mode will not be considered for evaluation.
- The winning design of logo(s) will be the intellectual property/ copyright of BBNL. The winner(s) cannot exercise any right over it, after the acceptance of the prize.
- The prize winning logo(s) may be used by BBNL for promotional and display purposes at its freewill including but not limited to printing, advertising and any digital platform.
- BBNL will have unfettered right to modify the prize winning logo(s) and add or delete any information or design feature in any form to it.
- Plagiarism of any nature is not allowed. Anyone found infringing on others' copyright would be disqualified from the contest.
- The logo design must be original and should not violate any provision of the Indian Copyright Act, 1957 or any other law applicable in this regard. The logo should not have been previously published in any print and digital media and must not contain any provocative, objectionable or inappropriate content.
- BBNL/ DoT/MyGov do not accept any liability for the publication of unlawfully reproduced logo(s). The participant submitting the entry shall be solely responsible for any liability arising out of the publication of unlawfully reproduced logo and consent to indemnify BBNL/DoT/ MyGov for the same.
- BBNL or MyGov takes no responsibility for corrupted or late entries.
- Employees of BBNL and DoT as well as their family members are not allowed to take part in this Contest.
- Participant(s) is/are required to ensure that his/her MyGov profile is accurate and updated since BBNL would be using this for further communication. This includes details such as name, photo, email-id, address and phone number. Entries with incomplete profiles will not be considered.
- The winner will be declared through email or by way of announcing his/her name on the MyGov blog page.
- There will be no notification to participants of rejected entries.

- Payment to the award winner will be made electronically through ECS for which necessary bank details will be taken after declaration of the winner(s) of the contest.
- BBNL reserves the right to cancel or amend all or any part of this Contest and/ or Terms and Conditions/ Technical Parameters/ Evaluation Criteria. However, any changes to the Terms and Conditions/ Technical Parameters/ Evaluation Criteria, or the cancellation of the Contest, will be updated/ posted on the MyGov platform. It would be the responsibility of the participants to keep themselves informed to any changes in the Terms and Conditions/ Technical Parameters/ Evaluation Criteria stated for this Contest.
- Any legal proceedings arising out of the competition/ its entries/ winners shall be subject to local jurisdiction of Delhi State only. Expenses incurred for this purpose will be borne by the parties themselves.

### **BharatNet Logo Contest Technical Parameters**

- Participants should upload the Logo in JPEG/ JPG/ PNG/ SVG format only.
- The Logo should be designed on a digital platform. The winner of the competition shall be required to submit the design in an editable and open file format. Participants should ensure that original designs are submitted.
- Logo should be designed in color. The size of the logo may vary from 5cm\*5cm to 60cm\*60cm in either portrait or landscape.
- The Logo should be usable on the website/ social media such as Twitter/ Facebook and on printed materials such as b/w press releases, stationery and signage, labels etc.
- The Logo should be in high resolution with minimum 300 DPI.

## **BharatNet Logo Contest Evaluation Criteria**

- All the entries received by BBNL would be scrutinized for awards by a selection Committee.
- Entries would be judged on the basis of elements of creativity, originality, composition, technical excellence, simplicity, artistic merit and visual impact and how well they communicate the theme of BharatNet.
- The decision of the Selection Committee would be final and binding on all the contestants and no clarifications would be issued to any participants or on any decision of the Selection Committee.
