

TERMS AND CONDITIONS OF Recharge Challenge – Season 7

PLEASE READ THESE TERMS & CONDITIONS (“T&C”) CAREFULLY BEFORE REGISTERING TO PARTICIPATE IN THIS CHALLENGE KNOWN AS **Recharge Challenge – Season 7**. BY PROCEEDING WITH REGISTRATION AND PARTICIPATION IN THIS **Recharge Challenge – Season 7**, YOU HEREBY ACKNOWLEDGE AND ACCEPT THE CHALLENGE AND THEREBY AGREE ON IRREVOCABLE BASIS, TO BE LEGALLY BOUND BY THESE TERMS & CONDITIONS. IF YOU DO NOT AGREE TO ABIDE BY THESE TERMS & CONDITIONS, PLEASE DO NOT PARTICIPATE IN THIS CHALLENGE.

1. Terms and Conditions:

The **Recharge Challenge – Season 7** (hereinafter referred to as a “**Challenge**”) is conceptualized, organized and conducted by OnMobile Global Limited having its registered office at Tower #1 94/1C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase-1, Bengaluru, Karnataka 560100 (hereinafter referred to as OnMobile) in association with Vodafone Idea Limited a company incorporated under the provisions of the Companies Act, 1956 and having its registered office at Suman Tower, Plot No. 18, Sector – 11, Gandhinagar – 382 011 and its corporate office at 10th Floor, Birla Centurion, Century Mills Compound, Pandurang Budhkar Marg, Worli, Mumbai 400030.

OnMobile and Vodafone Idea shall hereinafter be jointly or individually as the context may require be referred to as “**Organizer/s**”.

2. Eligibility Criteria to participate:

This Challenge is available only to the Active Subscribers¹ of Idea (prepaid) and who fulfill the following criteria:

- a) Subscriber must be of or above 18 years of age;
- b) Subscriber must be a resident of India;
- c) Subscriber must not be a resident of Telangana state;

¹ Active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in this Challenge or any other challenges offered by the Organizers.

Subscriber shall mean the rightful user of the Idea connection, in whose name the mobile phone number (MSISDN) is registered with the operator. In the event the number / connection is registered in the name of a company or firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate and authorization of the employer duly permitting the employee to use the MSISDN for participation in the Challenge, receive the gratifications and accept the terms applicable for the Challenge.

3. Nature of Challenge Procedure and Gratification

The Challenge is available on IVR, and MWEB

To Play on IVR (Voice) by calling on 552566.

To play on MWeb by visiting link:

Post recharge on any of the VAS Bundled UL Recharge user will be eligible to play the Challenge.

All questions are in multiple-choice format and the answer to each must be selected from one of the two options only. For every right answer, the Participant will get one [1] point. There is no negative marking for a wrong answer.

In IVR, the Participant will press “1” for option 1 or press “2” for option 2 on their phone keypad to

answer each question of the Challenge.

To answer questions Participants will have to answer appropriately by Call on 552566, which will be free.

There will be total 560 skill based questions. Participant can play maximum 20 questions in a day. After every answer, the Participant will be given an appropriate response followed by the updated score and given the next question and answer options.

The Participants may discontinue participating in the Challenge anytime by calling 155223 / Sending SMS "STOP" to 155223.

Participant can subscribe and unsubscribe to the Challenge any number of times during the Challenge validity.

During the playing of the challenge if a participant drops call, the same day the participant will get the same unanswered question. Post which Participant will receive the nth question and (n+1)th question. If the Participant does not receive question for any reason, the same process as above has to be followed.

(The challenge is available only on IVR).

*****Challenge Cycle:**

A Challenge Cycle is for 28 days and the participants can participate in one or more Challenge Cycles, based on the validity of recharge pack activated (End of a Challenge Cycle, participant who is having longer validity will be eligible to participate in the next Challenge Cycle without any additional recharge/s). The Gratification may/ will change for each Challenge Cycle.

Note: The participants who scores highest points in the least amount of time are eligible for Bumper Gratification in any of the Challenge during that particular Challenge Cycle.

The points scored in a particular Challenge Cycle will not carry forward for the next 28 days cycle.

e.g.: Participant, who is coming in between any two Challenge Cycles, after finishing the ongoing 28 days cycle, his/her scores for that Cycle will be considered only for the ongoing 28 days cycle gratifications. Zonal Bumper Gratification

- The selection for the Zonal Bumper Gratification will be conducted after the Challenge ends.
- 1 MSISDN per zone group**, with 10 points in the least amount of time, during the Challenge will become eligible for this Gratification.

Circle 1st Gratification

- The selection for the Circle 1st Gratification will be conducted after the challenge ends
- 1 MSISDN per Circle Group*, with a score of 5 points in the least amount of time, during the Challenge will become eligible for this Gratification.
- One Individual, irrespective of MSISDNs, can win only one of the above mentioned Gratifications

Note: In case of a tie in the selection in the Zonal Bumper Gratification and Circle 1st Gratification in Score and time taken , 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered

Circle 2nd Gratification

- The selection for the Circle 2nd will be conducted after the challenge ends
- 2 MSISDNs per Circle Group*, with a score of 2 point in the least amount of time, during the Challenge will become eligible for this Gratification.
- In case of a tie in the selection Circle 2nd Gratification the winner will be selected which MSISDN has achieved the score 1st in point of time. In case of a further tie, all eligible MSISDNs will be gratified.

Note: The time taken for answering a question on “Voice” mode, is calculated from the time OnMobile’s system plays beep (after question) till the answer DTMF input received by system., for the purpose of determining the relevant Gratifications under this Competition, respectively.

7. The Highest Scorer will be contacted/communicated through call/SMS/email for [3] consecutive days from the announcement of Challenge results. The Challenge results will be announced within 60 days. However, in case of any daily /weekly gratification, the communication about the Highest Scorers and the disbursement thereof will be done within 15 working days of the relevant day/relevant week. 19. The *Meet And Greet* event is subject to the availability of celebrity. The Organizer as per the availability of the celebrity may reschedule the *Meet And Greet* event or at their sole discretion reserve the right to substitute gratification(s) of equal or greater value at any time. However under no circumstance shall the Highest Scorer of the Challenge be entitled to redeem any category of gratification for cash.

20. To claim gratification/s under the Challenge, the MSISDNs/Participants chosen as the Highest Scorers shall be required to be Active Subscribers of Idea. The Highest Scorers shall not be entitled to the gratification in case the participant fails to clear all outstanding dues payable to Idea.

21. Participant hereby undertakes sole responsibility to check the result link post completion of the Challenge to know the Highest Scorer and to claim the gratification, if any.
