The Terms and Conditions can be amended or varied from time to time\_or withdrawn and therefore, please visit the Website to keep Yourself (defined below) updated and informed.
- b) The Contest is open for all Subscribers who satisfy the eligibility criteria mentioned in Clause

#### E. Charging:

#### E. Contest on Voice

Contest will be available on the toll-free number 56505050 for all Subscribers.

- (i) The questions under this Contest shall be based on general information available to the public at large.
- (ii) The Subscriber can press 1 for 1<sup>st</sup> option or 2 for 2<sup>nd</sup> option on the phone keypad to answer.
- (iii) After every question and answer options, a "beep" prompt will be played, post which Subscribers can answer the question.
- (iv) For every right answer the Subscriber will get 1 point. There is no negative marking for a wrong answer.
- (v) After every right or wrong answer, the Subscriber will be played an appropriate prompt followed by the Subscriber's updated score and the next question and option answers.

The time taken for answering a question is calculated from the time the question, answer and the "beep" prompts finish playing till the time the Subscriber provides an answer by pressing the relevant key.

- (i) To listen to a question again Subscribers can press\*

#### **Bumper Prize**

- The selection for the Bumper Prize will be conducted at the end of the contest
- 1 MSISDN across all circle-groups\* with highest cumulative points, in the least amount of time, during the contest will be selected as the winner.

- H. All gratifications will be given after deducting various taxes and charges as applicable.
