TERMS AND CONDITIONS – GOLD RUSH CONTEST

A. INTRODUCTION

- a) THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.
- b) PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS CONTEST KNOWN AS "GOLD RUSH". BY PROCEEDING WITH PLAYING THE, GOLD RUSH YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("Terms and Conditions"). B. Contest:

- a) "GOLD RUSH" (hereinafter referred to as the "Contest") is conceptualized, organized and conducted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India ("OnMobile" or "Organizer") for active¹ pre-paid and post-paid category of Subscribers² ("Subscriber(s)") of Bharat Sanchar Nigam Limited a company having its registered office at Bharat Sanchar Nigam Limited, (NS Branch), 10th Floor West Wing, Chandralok Building, Janpath, New Delhi 110001 (hereinafter referred to as "BSNL Mobile") and is valid during the period from, 16th February 2019 00:00:01 hrs to, 16th April 2019 23:59:59 hrs, both days inclusive, Organizer reserves the right to extend or shorten the Contest Period, as it deems fit, and any such change shall be published on the website, www.bsnl.contestzone.in ("website"). The Terms and Conditions can be amended or varied from time to time_or withdrawn and therefore, please visit the Website to keep Yourself (defined below) updated and informed.
- b) The Contest is open for all Subscribers who satisfy the eligibility criteria mentioned in Clause

<u>C.</u> The Contest will be available in the below mentioned languages:

Kannada, Malayalam, Telugu, Hindi, English, Bengali, Oriya, Gujarati, Marathi, Punjabi and Tamil.

A Subscriber by participating in the Contest, hereby agrees to the Terms and Conditions mentioned below and gives the Subscriber's irrevocable consent to the process of selecting the winners (defined below) under this Contest as set out herein, and any appropriate changes that may be made to this Contest by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever.

Subscribers who are roaming outside their home Circle will not be able to subscribe and play the Contest.

Further, the Subscribers who participate in the Contest and are chosen as winners under each category of gratification in accordance with the winner selection process detailed in these Terms and Conditions will be the registered BSNL Mobile Subscribers of the winning mobile phone number and not merely the players using such mobile number ("winner(s)"). D. To Subscribe:

A Subscriber can subscribe to the Contest either by:

- ii. Once a Subscriber calls 56505050, the system checks if the caller has already subscribed to the contest or not.
- iii. If a Subscriber wants to unsubscribe from the contest, then it can be done by calling the toll-free number 155223.

E. Charging:

Once an MSISDN subscribes to the contest, the MSISDN will be charged Rs.5/day. All Subscribers will be allowed to play the Contest daily only after being successfully charged Rs.5 for that day. After playing these 5 Questions, users will be moved to PPU model where they can play the 1st question. After answering 1 question, user will be charged and post charging,

they can play the next 4 Questions for free. So user will be charged Rs 5 at the interval of 5 Questions. This will be continued till 20th Questions of PPU. Total a user can play 5 Questions on Subscription Model and 20 Questions on PPU Model in a day. If the charging is successful, such Subscriber will get a confirmation SMS on the Subscriber's number registered with BSNL Mobile along with the rules, gratifications, Terms and Conditions URL, and the number on which Subscriber can call and participate in the Contest. If the charging is unsuccessful, the Subscriber will be sent an SMS on the Subscriber's number registered with BSNL Mobile, informing subscribers of such unsuccessful charging.

The above mentioned charges shall be deducted only after seeking Subscriber's double consent for participation in the Contest; immediately after the recharge is done by the Subscriber. The above applicable amount will only be charged post subscription through consent gateway i.e. second/final consent.

Note: Fall-back charging will not be applicable for post-paid Subscribers as charging happen on base price.

E. Contest on Voice

Contest will be available on the toll-free number 56505050 for all Subscribers.

- (i) The questions under this Contest shall be based on general information available to the public at large.
- (ii) The Subscriber can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer.
- (iii) After every question and answer options, a "beep" prompt will be played, post which Subscribers can answer the question.
- (iv) For every right answer the Subscriber will get 1 point. There is no negative marking for a wrong answer.

(v) After every right or wrong answer, the Subscriber will be played an appropriate prompt followed by the Subscriber's updated score and the next question and option answers.

The time taken for answering a question is calculated from the time the question, answer and the "beep" prompts finish playing till the time the Subscriber provides an answer by pressing the relevant key.

- (i) To listen to a question again Subscribers can press*
- (ii) If a Subscriber stops playing the Contest after answering the nth question on any day during the Contest Period, then when the Subscriber calls back on the toll-free number 56505050, the Subscriber will be played the (n+1)th question. If a Subscriber stops playing the Contest without answering the nth question then when the Subscriber calls back on the toll-free number 56505050, the Subscriber will be played the nth question which may be different from what the Subscriber received previously i.e., if a Subscriber listens to the 2nd question but drops the call without answering the 2nd question, then when the Subscriber calls back, the Subscriber will be played the 2nd question which may be different from what the Subscriber received previously.
- (iii) The Subscriber will be played the questions one after the other till the Subscriber finishes answering all the questions for the Contest.

The selection for the Bumper Prize will be conducted at the end of the contest

1 MSISDN across all circle-groups* with highest cumulative points, in the least amount of time, during the contest will be selected as the winner of Gold worth up to Rs 50,000.

(ii) Zonal Bumper Gratification

The selection for the Zone Bumper Prize will be conducted at the end of the contest

1 MSISDN per zone -groups* with highest cumulative points, in the least amount of time, during the contest will be selected as the winner of a Smartphone worth up to Rs 10,000.

One individual winner irrespective of the MSISDN can win only one of the above prizes.

In the selection of Bumper Prize and Zone Bumper Prize in case of a tie in the score and in the time taken to answer, 1 round of tie-breaker will be conducted for all the tied MSISDNs. (iv) Daily Bumper Gratification

(v) Daily First Gratification

5 MSISDN across circle groups* with minimum score of 3 points, on that day, in the least amount of time, is selected as the winner of a Mobile Recharge worth up to Rs 50.

1 MSISDN can win this Prize only once in the contest

In case of a tie in the selection of the Daily and Weekly Prizes, the winner will be selected which MSISDN has achieved the score 1st in point of time.

The points scored by an MSISDN from the questions that the MSISDN is entitled to answer in a day, based on that day's charged value will only be considered for selection.

The time taken for answering a question on "Voice" mode, is calculated from the time OnMobile's system plays question till the answer DTMF input received by the system. On USSD channel time taken is calculated from the time system pushes the question till the answer input received by system.
