#### **Terms and Conditions:**

This GRAND FESTIVAL DHAMAKA QUIZ is conceptualized, organized and conducted by OnMobile Global Ltd, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India (hereinafter referred to as "OnMobile") as part of Players Zone. The GRAND FESTIVAL DHAMAKA QUIZ is valid and open for a limited period 14<sup>th</sup> September 2019 08:00:00 hrs till **12<sup>th</sup> December 2019 22:00:00 hrs,** both day inclusive, for the active<sup>1</sup> pre-paid as well as post-paid category of Airtel Subscriber(s)<sup>2</sup> ("Subscriber(s)") who have successfully subscribed to the Players Zone ("Players Zone Member(s)/ User(s)")(airtel means Bharti Airtel Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Bharti Crescent, 1, Nelson Mandela Road, Vasant Kuni, Phase II, New Delhi – 110 070, India (hereinafter referred to as "Airtel") and who belong to the following Airtel telecom circles of DELHI, UTTAR-PRADESH-WEST, UTTAR-PRADESH-EAST, JAMMU & KASHMIR, PUNJAB, HARYANA, HIMACHAL PRADESH, ANDHRA-PRADESH (excluding Telangana state), KERALA, KARNATAKA, MUMBAI, MAHARASTRA, GUJARAT, MADHYAPRADESH, RAJASTHAN, KOLKATA & WEST BENGAL, ORISSA, BIHAR, NORTH EAST & ASSAM, TAMIL NADU and CHENNAI ("Circle(s)"). ONMOBILE AND AIRTEL SHALL HEREINAFTER JOINTLY OR INDIVIDUALLY AS THE CONTEXT MAY REQUIRE BE REFERRED TO AS "ORGANIZER(S)"

For the purposes of these Terms and Conditions, wherever the context so requires "**You**" or "**Your**" shall mean any natural person who is a Players Zone Member and conditions of the Players Zone shall be deemed to be incorporated herein.

Also, by participating in this Quiz, You:

- i. Warrant that You have read, understood and agreed to confirm to these Terms and Conditions.
- ii. Warrant the accuracy, truthfulness and currency of all information that You may have

submitted.

- iii. Agree that You are entering into this Quiz as an independent party and nothing herein establishes an employer-employee relationship between You and Airtel or between You and OnMobile and You are acting voluntarily, using Your own time and resources to participate in the GRAND FESTIVAL DHAMAKA QUIZ, solely at Your own risk.
- iv. Warrant that prior to participating in the **GRAND FESTIVAL DHAMAKA QUIZ**, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein and the terms and conditions under Players Zone.

The Terms and Conditions can be amended or varied from time to time or withdrawn, without any prior intimation to You and therefore, please visit the Website periodically to keep Yourself updated and informed.

By subscribing to Players Zone and participating in this Quiz, You indicate Your acknowledgement and acceptance of these Terms and Conditions and the terms and conditions of the Players Zone.

#### 2. Procedure and Eligibility to participate:

This Quiz is valid for Subscribers who fulfill the following criteria:

- i. Subscriber/ Player's Zone Member must be of at least 18 years of age;
- ii. Subscriber/ Player's Zone Member must be a resident of India;

iii. Subscriber/ Player's Zone Member must not be a resident of Telangana State. iv.

Subscriber/ Player's Zone Member must be an existing Airtel Subscriber of any of the Circles

mentioned herein;

- v. For Prepaid Subscribers-Subscribers must have the requisite balance of Re. 1 per day, to be eligible to participate in the Quiz for that day;
- vi. Subscriber/ Player's Zone Member must be a Players Zone Member;
- vii. Subscriber/ Player's Zone Member must be an active Subscriber;
- viii. Subscriber/ Player's Zone Member must not have been either convicted and / or prosecuted for commission of any criminal offence nor be of an unsound mind; and
- ix. Subscriber/ Player's Zone Member must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship.

Further, the Player's Zone Members who participate in the **GRAND FESTIVAL DHAMAKA QUIZ** and are chosen as winners under each category of gratification in accordance with the winner selection process detailed in these Terms and Conditions will be the registered Players Zone Members of the winning mobile phone number and not merely the players using such mobile number ("**Winner(s)**"). If the Winner is not able to provide sufficient evidence to show that Subscriber/Players Zone Member is the Subscriber of the mobile number, the Organizer reserves the right to award the gratification to the next eligible Winner or to forfeit the gratification, at its sole discretion.

#### 3. To Subscribe to Players Zone:

#### A. Airtel Subscriber can subscribe to the Players Zone by:

- Typing the keyword 'START' and sending the SMS to 55000 (Toll-Free).
- Calling the (Toll-free) number 55000
  - Once the Subscriber calls 55000, Subscriber/ Players Zone Member is asked to press 2 to subscribe. After pressing 2 for double confirmation, Subscribers have to press 5.
- Dialing the Unstructured Supplementary Service Data ("USSD") String \*646\*3#
  - If the Subscribers dial the USSD string to subscribe, they will receive a confirmation SMS on their MSISDNs registered with Airtel and are required to respond by pressing 1 for double confirmation.
- On subscribing through any of the above mentioned modes, the successful Subscriber will receive an acknowledgement SMS on Subscriber's MSISDN registered with Airtel telling Subscriber that Subscriber's subscription request has been accepted.
- Players Zone membership is valid until such time as the Subscriber chooses to unsubscribe from the Players Zone.

• Once the Subscriber has successfully subscribed, Subscriber/ Players Zone Member will get an SMS on Subscriber's MSISDN registered with Airtel informing Subscriber about the current or upcoming quizzes, gratifications to be won and that the current Quiz can be played at just Rs.5,

Rs. 4, Rs. 3, Rs. 2 or Re. 1 per day, depending on the balance available on Subscriber's MSISDN registered with Airtel.

- On non-quiz days the Players Zone Members will not be charged i.e., for the period between the end of one quiz and before the start of the next quiz.
- Players Zone Members will be automatically eligible to play all quizzes launched as a part of Players Zone.
- If a Players Zone Member wants to unsubscribe from the Players Zone then it can be done by typing 'END' and sending it as an SMS to 55000 (Toll-free) or by calling the toll-free number 543212903/155223 or by sending 'STOP' as an SMS to 155223 (toll-free) or dialing USSD string \*646\*4#. - The day after the quiz ends, an SMS will be sent to the all active Players Zone Members informing them that the quiz is closed and to watch out for the next quiz.
- All existing and new Players Zone Members will be sent an SMS on their number registered with Airtel before the launch of a quiz, informing them about the upcoming quiz.
- The SMS will contain the method of unsubscribing from the Players Zone.

#### 4. Charging

All existing Players Zone Members as on the 1<sup>st</sup> day of the Quiz and all Airtel active Subscribers who subscribe to the Players Zone after the Quiz starts, will be charged Rs. 5/-, Rs. 4/-, Rs. 3/, Rs.2/- or Rs. 1/- per day ("**Daily Charging Amount**"), depending on the available balance on Subscriber's MSISDN registered with Airtel, on that day from 01:00:00 hours onwards<sup>3</sup>. All Players Zone Members will be charged from the 1<sup>st</sup> day of the Quiz, or the day that Subscriber/ Players Zone Member subscribes to the Players Zone, till the end of the Quiz, or till the day Subscriber/ Players Zone Member unsubscribes from the Players Zone, whichever happens first, irrespective of whether the Players Zone Member plays the Quiz or not. The Daily Charging Amount is charged each day, irrespective of successful charging or failure the previous day. This Daily Charging Amount will not be refunded to Players Zone Member under any circumstances

All Players Zone Members, on the first day that Subscriber/ Players Zone Member participates in the Quiz will be sent a success SMS on Subscriber's MSISDN (if the charging is successful) which shall include without limitation the number on which Subscriber/ Players Zone Member can participate in the Quiz, rules, gratifications to be won, Terms and Conditions URL of the Quiz.

Every 15 days from the date of commencement of the Quiz till its completion, all active Players Zone Members will be sent a reminder SMS on their MSISDN's registered with Airtel informing them that they are active on Players Zone and such SMS shall detail the process of unsubscription from the Players Zone. All Players Zone Members will be allowed to play the Quiz each day irrespective of successful charging on each day. If the charging fails for any particular day during the Quiz, the Players Zone Member will be allowed to play the Quiz for that day, however the questions attempted by such Players Zone Member shall not be considered for the Winner selection process for any of the gratifications under the Quiz for which the Participant is not charged prior to end of the Quiz. All Players Zone Members will be allowed to play the Quiz for which the Participant is not charged prior to end of the Quiz. All Players Zone Members will be allowed to play the Quiz each day irrespective of successful charging for 5 consecutive days during the Quiz period. Post 5 consecutive days of on 0 (zero) balance, Participant will have to be charged for the previous days questions first and then for the current days question will be given and subsequently charged.

On subsequent days, the system will charge all eligible Players Zone Member Rs. 5/-, Rs. 4/-, Rs. 3/-, Rs. 2/- or Rs. 1/- per day, depending on the available balance on Subscriber's MSISDN registered with Airtel, at 01:00:00 hrs each day of the **GRAND FESTIVAL DHAMAKA QUIZ** through an automated charging system<sup>4</sup>, irrespective of successful charging or failure the previous day, till the completion of this **GRAND FESTIVAL DHAMAKA QUIZ** or till the day Subscriber/ Players Zone Member unsubscribes from the Players Zone, whichever happens earlier. #### 5. Playing Rules:

The GRAND FESTIVAL DHAMAKA QUIZ consists of a total of 450 questions, with 2 answer options for each question. A Players Zone Member can play only up to 5 questions each day. All questions are in Multiple choice format and the answer to each must be selected from one of the 2 options only. There will be a fresh set of 5 questions every day.

The questions under the GRAND FESTIVAL DHAMAKA QUIZ shall be based on information available to the public at large.

After every answer, the Players Zone Member will be informed if the given answer is right or wrong, followed by the updated score and given the next question and answer options. The Players Zone Member shall also be informed the total score which shall be based on the days of successful charging (which will consider the charging and score update the day before the previous day).

For every right answer the Players Zone Member will get 1 point. There is no negative marking for a wrong answer.

If the Players Zone Member stops playing the **GRAND FESTIVAL DHAMAKA QUIZ** after answering the nth question then when Subscriber/ Players Zone Member resumes on the same day by calling the number 55000 (toll free) or sending the keyword 'GET' through SMS to 55000 (toll free), Subscriber/ Players Zone Member will be given (n+1)th question. If Players Zone Member stops playing the GRAND FESTIVAL DHAMAKA QUIZ without answering the nth question then when Subscriber/ Players Zone Member resumes playing on the same day, Subscriber/ Players Zone Member resumes playing on the same day, Subscriber/ Players Zone Member listens to the 4<sup>th</sup> question but drops the call without answering the 4<sup>th</sup> question, then when Subscriber/ Players Zone Member calls back on the same day, Subscriber/ Players Zone Member will be played the 4<sup>th</sup> question of the day, which may be different from what Subscriber/ Players Zone Member received previously, similarly if Players Zone Member will be played the 4<sup>th</sup> question of the day, which may be different from what Subscriber/ Players Zone Member received previously, similarly if Players Zone Member will get 4<sup>th</sup> question that may be different from the 4<sup>th</sup> question Subscriber/ Players Zone Member will get 4<sup>th</sup> question that may be different from the 4<sup>th</sup> question Subscriber/ Players Zone Member received before.

Irrespective of whether or not the Players Zone Member has answered all 5 questions on a particular day, when Subscriber/ Players Zone Member attempts on the next day, Subscriber/ Players Zone Member will be provided the first question of that day.

If a Players Zone Member has answered only 3 questions the previous day and sends the answer to the 4th question the next day, then that will be considered as the answer to the 1st question of the new day and response will be sent accordingly if the 1st question has been pushed to the Players Zone Member. The Players Zone Member will be provided the questions one after the other till Subscriber/ Players Zone Member finishes answering all the questions for that day.

If a Players Zone Member stops playing the Quiz on voice on any particular day, Subscriber/ Players Zone Member may continue playing the remaining questions of that particular day on SMS by sending "GET' as an SMS to 55000 to receive the next question and answer options. If a Players Zone Member stops playing the Quiz on SMS, Subscriber/ Players Zone Member can resume playing on the same day by calling 55000.

There will be a black-out time for **GRAND FESTIVAL DHAMAKA QUIZ** every day between 11:45 PM to 12:15 AM. The black-out time will be communicated to all the Players Zone Members at the time of subscription to Players Zone. During this black-out period, the Players Zone Members will not be allowed to play the **GRAND FESTIVAL DHAMAKA QUIZ**.

The points scored by the Players Zone Member in a day will not get carried over to the next day. Subscriber's score will be reset to zero at the start of each day. The selection of the Winner for the Daily Gratification for each day of the Quiz will be based only on the points scored by a Players Zone Member for each day of the Quiz.

Players Zone Members who are roaming outside their home Circles will not be barred from subscribing to the Players Zone and/or participating in the Quiz.

- If Players Zone Member answers questions on a particular day without being charged on that day but gets charged on a later day then points scored by Players Zone Member on that day will be considered for all the gratifications whose winner selection is done at end of the Quiz only. These points will not be considered for the gratifications whose winner selection is done in middle of the Quiz.

Subscribers hereby agree and confirm that Subscriber is aware that an SMS sent by the Subscriber may not be received by the Organizers instantly due to various factors outside the control of the Organizers such as Network failure or System failure and hereby agrees not to dispute/challenge the delay caused hence. The time for recording of answer shall be the time at which the Organizer receives the answer and not the time at which the Subscriber sends an answer from his/her handset. For example – If a subscriber sends an answer at 2 PM but it was received by Organizers only at 3 PM, then 3 PM will be considered for Winner Selection. The Subscriber undertakes not to challenge the selection process of winner(s) in case of tie in the number of points scored, since the time at which the SMS was received by Organizers will be considered for selecting the winner.

Subscribers hereby undertake sole responsibility to check the result link provided on a daily basis post completion of Challenge to know the winner and to claim their gratification, if any. Post winner declaration and completion of their announcement and further process as the case

may be if Organizer finds that the declared winners are wrong then organizer reserves the right to declare the correct winners again and cancel the gratification of winners declared earlier.

#### 6. On Call:

- i. All Players Zone Members can play the **GRAND FESTIVAL DHAMAKA QUIZ** each day of the Quiz by calling the toll-free number 55000.
- ii. The Players Zone Members can press 1 for 1st option or 2 for 2nd option on the phone keypad to answer any question.
- iii. Players Zone Member can answer only after the Beep.

Players Zone Members can press 8 to listen to a question again.

#### 7. Quiz on SMS:

The **GRAND FESTIVAL DHAMAKA QUIZ** will be available on the toll-free number 55000 for Players Zone Members.

All Players Zone Members can play the Quiz, on the toll-free number 55000, by sending 'GET' to 55000.

All active Subscribers of the Players Zone can play the Quiz by sending 'GET' as an SMS to the toll-free number 55000.

A Players Zone Member can play the Quiz either by sending the keyword "GET" to 55000 to receive the question followed by sending GET 1 or GET 2 or just 1 or 2 as an SMS to 55000 as their response to the question, or by sending a response like GET 1 or GET 2 or just 1 or 2, without the keyword GET, as an answer to the question that Subscriber/ Players Zone Member last received on that particular day.

In case a Players Zone Member experiences a delay in receiving a response or receives no response at all from the system, at any time during the Quiz period, Subscriber/ Players Zone Member is required to SMS the Quiz keyword 'GET' to the toll-free number, 55000. The Players Zone Member should refrain from sending the answer options, '1' or '2' in such a situation, as it may be considered as a reply to an unanswered question.

There will be a black-out time of 30 minutes from 11:45 PM to 12:15 AM of the next day. The black-out time will be communicated to the Players Zone Members at the time of subscribing to the Players Zone. The Players Zone Members will not be allowed to play the Quiz during this black-out time.

If the OnMobile system receives responses like GET 1 or GET 2 or just 1 or 2 after 12.15 am then that will be considered as response to the 1st question of the new day and based on the right answer configured for the 1st question of the day, the response will be sent along with the next question.

#### 8. Quiz Flow on USSD \*646\*3#

Quiz will be available on \*646\*3# USSD String for subscribers of the Players Zone.

Format of question and answer options will be as mentioned in the below example. Every question will have a pre-question text in set 1 that will introduce Players Zone Member to the Quiz E.g. Q1. What is....?

1) XYZ

2) ABC

Send 1 or 2

Quiz consists of 450 questions, which can be answered by Players Zone Members at any time. Once Players Zone Member completes Set 1, Subscriber/ Players Zone Member will be taken to Set 2 and so on.

All the questions have 2 answer options each and Players Zone Members can answer by sending 1 / 2, as a response to the questions.

All subscribers can play up to 5 questions a day. There will be a fresh set of 5 questions every day.

Subscribers with status as "Suspended" will be allowed to play only for 5 consecutive days.

For every right answer the Players Zone Member will get 1 point. There is no negative marking for a wrong answer and call-to-action.

After every right/wrong answer, the Players Zone Member will be sent USSD message giving Subscriber's score for the day, followed by the next question and call-to-action.

If the Players Zone Member gives an invalid input then an SMS is sent saying invalid answer, followed by how to answer.

In case of an invalid USSD input, a random unanswered question is sent to the Players Zone Member.

If Players Zone Member stops playing after answering the nth question then when Subscriber/ Players Zone Member sends dials USSD string again, Subscriber/ Players Zone Member will get the (n+1)th question on USSD.

## **Bumper Prize**

- The selection for the Bumper Prize winner will be conducted after the Quiz ends.
