COMPETITION TERMS & CONDITIONS

- 1. Please read these terms & conditions (*Terms*) carefully. By entering the **Bheem Sangg Dabaang** Competition (*Competition*), you are agreeing to be bound by these Terms. You should also read our privacy policy at www.pogo.tv which explains how Turner will use the data you provide at the time of entry or during the Competition.
- 2. This Competition is being organized and operated by Turner International India Private Limited (*Turner*), 5th Floor, Radisson Commercial Plaza, National Highway No.8, Mahipalpur, New Delhi 110037, India.
- 3. All natural persons who are legal residents of India and are aged up to 14 years (*Participants*) are eligible to enter the Competition for free. - 4. Entry

- 8. The Competition commences 15 December 2019 at 11:00 AM and will end on 15 December 2019 at 02:00 PM (Indian Standard Time) (*Competition Period*). Entries received before or after the Competition Period are void.
- 9. Participants may enter by:
 - a) acting in accordance with these Terms;
