

Terms & Conditions

“TIMES NOW NAVBHARAT – Dekhega Navbharat Jeetega Bharat” Contest

By participating in the “TIMES NOW NAVBHARAT – Dekhega Navbharat Jeetega Bharat” on TIMES NOW NAVBHARAT (hereinafter referred to as the (“**Contest**”), you agree to have read, understood, and accepted the following terms: -

These terms, conditions, and guidelines (“**Terms**”) are applicable to and govern the Contest organized and conducted by Bennett, Coleman & Company Limited (“**BCCL**”), for its Hindi News channel **TIMES NOW NAVBHARAT** (shall be referred to as ‘**Channel**’). By accessing this document/post/website/participating in the Contest you (“**You/ Participant/Participants**”) agree to abide by and be bound by these Terms. BCCL reserves the right to modify these Terms without any prior notification. You are hereby advised to regularly review these Terms. If you do not agree with any of the Terms and any amendments thereto, you must not use this site and/or participate in the Contest. Participation is voluntary and optional.

- The Contest is open only to Indian Citizens residing in India and who are at least 18 years of age or older on the date of participating in the Contest.
- Employees, directors, and/or officers (including immediate family members or members of the household) of BCCL, its subsidiaries, partners, affiliated companies, distributors, advertising, fulfillment and promotion agencies and all other companies or entities associated with the Contest are not eligible to participate.
- The duration of the Contest is from April 20th 2022 to July 28th 2022 (both days inclusive) from 6 a.m to 12 midnight (“**Contest Period**”).
- Participants are required to give full details of their name, permanent address, permanent account number (PAN), phone number, age and such other details as may be required by BCCL.  - By giving a missed call to the number flashed on the Channel, the Participants hereby grants consent to receive promotional messages.
 - Upon giving a missed call and granting consent, the Participant will receive a question along with 2 optional answers. Each optional answers will have different mobile numbers and the Participant is required to give a missed call to the number given against the optional answer, which the Participant thinks is the right answer.
 - Upon giving a missed call the Participant will receive “Thank you for participation” SMS as an acknowledgement. All Winners of the day will be declared on the fifth (5th) day after the Contest Day.
