### TERMS AND CONDITIONS FOR CALL FOR ENTRY

#### FOR THE CONTEST TITLED "CHAMBAL REFINED SOYABEAN OIL PRESENTS PEHLI

#### RASOI ("CONTEST")

These Terms And Conditions ('Terms and Conditions') govern your participation in the "Chambal Refined Soyabean Oil Presents Pehli Rasoi Contest" (the "Contest") being conducted by Viacom18 Media Private Limited ("Company" or "we" or "Viacom18") as per the terms stated hereinbelow. Viacom18 is calling for Call for Entries for the Contest and conducting the selection of contestants ("Selection Process") as per the process laid down hereunder. The Terms and Conditions of and in relation to this Selection Process and the Contest as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This is a legal and binding agreement between the You/Participant(s) and Viacom18, that states the terms that govern the Participant's participation in the Selection Process and the Contest through the Participation Mechanism (as stated hereinbelow) and/or any other platform as communicated hereunder.

These Terms and Conditions apply to all users ("You/Participant(s)") who intend to participate in the Contest. By choosing to proceed with Your comments on the Social Media Posts (defined hereinbelow), You agree to have read, understood, and be bound by these Terms and Conditions. Your comments on the Social Media Posts constitute Your participation in the Contest and Your agreement to follow and be bound by these Terms and Conditions without modification, and all other operating rules, policies and procedures that may be published from time to time by the Company. If You do not agree to these Terms and Conditions, You are advised not to participate in the Contest. Please be advised if You choose to continue to participate in the Contest, it shall be deemed that You have read and accepted the Terms and Conditions. The Terms and Conditions are personal to You, and are not assignable, transferable or sub-licensable by You.

The Contest invites Participant(s) to participate in the Contest by posting their comments on the Social Media Posts during the Contest Period (defined hereinbelow) and following all required mandates herein below.

# 1. Participation mechanism and Contest procedure:

- i. The Participant(s) can participate in the Contest in the following manner:
  - a. Participation through Social Media Handles: The Call for Entries for the Contest will be made by influencers and television actors through their respective Facebook, and Instagram handles as well as by Viacom18 through posts on the ColorsTV's official Facebook and Instagram handle or the Contest sponsor's Facebook and Instagram handle ("Social Media Posts"). To participate in the Contest, the Participant(s) must comment on the foregoing Social Media Posts with their most memorable moments of their own personal "Pehli Rasoi" experience and/or their own personal experience of the Pehli Rasoi of their immediate family members in which they played a memorable/interesting role, to participate in the Contest.

The Participation through the platforms as communicated herein shall collectively be referred to as 'Participation Mechanism'.

b. Out of all the comments received on the Social Media Posts within the Contest Period, Viacom18 shall select a maximum of 3 (three) contestants as winners ("Winners") who have given the most interesting, and memorable experiences. The selection of the Winners shall be determined by Viacom18 at their sole discretion as per their creative requirements and policies.

The Winners will be selected and intimated to the concerned Participant(s) via an Instagram direct message sent through the official ColorsTV handle within 15 (fifteen) days from the expiry of the Contest Period or such other timeline as Viacom18 may determine in its sole discretion. The Winners will have to provide the relevant details including but not limited to a) name, b) age; c) Address; d) nationality e) contact number; g) city ("Contact Details") on the message trail.

- ii. Gratification: The selected 3 (three) Winners will be invited to Mumbai and will get a chance to be a part of a cooking video with Ms. Smita Bansal ("Program") and the Winners shall receive Chambal Soyabean Oil for 12 months i.e., 5 Litres of jar each month. The Program will be uploaded on Viacom18's digital internet video platform service presently branded as "Voot", Viacom18's YouTube channels, and such other platforms as Vaicom18 may determine at its sole discretion.

- v. The Participant(s)' participation in the Contest shall only be considered as valid only upon the Participant(s)' submission of all the details as required by Viacom18. The Participant(s) undertake to sign all documents/forms/release letters/declaration/consent letters, etc as may be required by Viacom18 from to time in relation to the Contest.

# 4. Eligibility Criteria:

Participants above 21 (twenty one) years of age who are legally residing in India are eligible to participate in this Contest. However, Viacom18 may at any time and as per its sole discretion, impose or modify the age limit/restrictions of the Participants who would be eligible to participate in the Contest or any of its subsequent rounds (if any).

Participant(s) hereby represent and confirm that they are above 18 (eighteen) years of age as on the date and time of participating in the Contest and that they completely understand the nature of the Contest and that they have voluntarily chosen at their free-will to participate in the Contest and are willing to

bear all risk, costs & consequences arising from such participation in the Contest and/or subsequent contests.

#### 5. Contest Period:

The Contest Period shall commence from 28<sup>th</sup> December 2023 and shall tentatively conclude on 10<sup>th</sup> January, 2023 or such other date as may be decided and updated by Viacom18 and/or modified at the sole discretion of Viacom18 ("Contest Period") and the same shall be updated and informed by Viacom18 in any manner as it deems fit. It shall be the responsibility of the Participants to keep themselves updated with respect to any change/modification in the Terms and Conditions and/or as informed by Viacom18 and any such modification shall apply to all the Participants and the Participants shall be bound by the amended / modified terms and conditions.

## 7. **Term:**

These Terms and Conditions, all Rules (as defined hereinafter) contained herein shall subsist until end of the Contest Period and/or any such extended duration as may be deemed fit by Viacom18.

#### 8. Rules:

In the event of large number of registrations, participation, the chance to be considered as a winner of the Contest shall be as per the sole discretion of Viacom18. Further, Viacom18 shall have a sole discretion to decide on the number of winners. You agree and undertake to abide at all times by all the rules, regulations, terms and conditions for this Contest as laid down herein and as determined from time to time by Viacom18 (the "Rules"). You agree and acknowledge that the Rules, may be changed at any time by Viacom18 including but not limited to cancelling or postponing the Contest and/or introducing new/subsequent rounds/levels and/or changing the format of the Contest and/or introducing wild card rounds of the Contest and/or otherwise and You will be bound by such altered/changed / new Rules/new terms and conditions. - 8.7 If Viacom18 so elects, Winners will be required to submit to a confidential background check to confirm eligibility and may even be required to sign a release letter on the format provided by Viacom18 and help ensure that the Winners will not bring Viacom18 and/or its entities into public disrepute, contempt, scandal or ridicule or reflect unfavorably on Viacom18 as determined in their sole discretion.
- 8.8 You hereby confirm that You are medically, physically and mentally fit and sound and that You do not have any kind of medical/physical/mental/emotional condition (including without limitation any heart ailment, blood pressure, final stages of pregnancy and/or psychological, anxiety, hypertension, depression, disease / disorder and/or any other medical problems of any kind whatsoever, etc.) which can jeopardize your participation in the Contest.
- 8.9 If for any reason the Contest is not capable of being executed as planned, due to, including without limitation infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, on any of the Participation Mechanism and/or due to any other causes which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, Viacom18 reserves the right, at its sole discretion, to disqualify any Participant(s) who may be responsible or who tampers with the entry /Contest process, and to cancel, modify or terminate the Contest. terms and conditions hereof including terms and conditions of any agreement entered into with Viacom18 and/or any terms and conditions otherwise stated/prescribed, any act including any unlawful act, omissions, misconduct, performance, harm caused to any person / party during the Contest, any violation of any applicable laws by You and/or any such claims, losses, damages and liabilities arising out of Your participation in the Contest. - 8.31 The grant of rights, representations, warranties, indemnities given by the Participant(s) and the Participant's confidentiality obligations contained herein and any such provision that is intended to survive and/or by its very nature should survive, shall survive the expiration of the Term as contained herein.
- 8.32 In case of any dispute or difference in respect of above, the decision of Viacom18 shall be final and binding on all parties/persons.
- 8.33 The Terms and Conditions shall be governed, interpreted by and construed in accordance with the laws of India and the Courts of Mumbai, India shall have sole and exclusive jurisdiction over any suit or other proceeding arising out of or based upon this terms and conditions.
- 8.34 YOU AGREE, CONFIRM, AND DECLARE THAT THE INFORMATION YOU HAVE PROVIDED / SUBMITTED IS TRUE AND CORRECT AND YOU FURTHER AGREE THAT YOU HAVE READ AND UNDERSTOOD THE TERMS AND CONDITIONS FOR YOUR PARTICIPATION AND YOU HEREBY CONFIRM TO COMPLY WITH THE SAME. ALL INFORMATION GIVEN BY YOU, WHETHER ORALLY OR IN WRITING IS TRUE AND COMPLETE AND THAT YOU SHALL BE RESPONSIBLE AND LIABLE TO INDEMNIFY VIACOM18, IT'S AFFILIATES, CONTRACTORS / REPRESENTATIVES / AGENTS / PARTNERS AGAINST ANY LOSS/DAMAGE/CLAIMS, ETC. ARISING DUE TO ANY MISREPRESENTATION AND/OR INCOMPLETE INFORMATION PROVIDED BY YOU AND YOU AGREE TO BE BOUND BY THE RULES AND TO THE TERMS AND CONDITIONS SET OUT ABOVE.
