#### TERMS AND CONDITIONS

#### Duma Dum Diwali with Sonu Nigam Contest ("Contest")

- This Contest is organized by Viacom 18 Media Pvt. Ltd. ("Organizer"), and is open to all individuals, and who meet the following requirements for participation ("Participant/ User"):
  - 1.1. are citizens of India;
  - 1.2. are above 18 (Eighteen) years of age (Participation by minors will be deemed as participation with the prior consent and knowledge of the Participant's parents/ guardians.   - 1.5. are mobile subscribers of Bharti Airtel, Vodafone Idea (VI), Mahanagar Telephone Nigam Ltd., Mumbai, Bharat Sanchar Nigam Ltd., and Jio ("Service Provider"); and
  - 1.6. have a valid Aadhar card and Permanent Account Number card;
  - 1.7. <u>are not winner or rejected winner of the former Contest(s) held by the Organizer</u> <u>prior to the current year.</u>
- 2. To participate in the Contest, a Participant need to provide the correct answer for 1 (one) question that shall be posted on the Channel or posted on any other platforms, as may be determined by the Organizer during the Contest Period (as defined hereinafter) through Modes of Participation, as provided below ("Contest Entries"). This is a daily contest, where there will be 1 (one) question posted on the Channel, every day, of each week of the Contest Period (defined below). - 3.   - (vii) The participant understands that once the Contest Entries are submitted, the process gets completed, the participant shall not be able to change/edit or delete the said Contest Entries.
