TERMS AND CONDITIONS FOR THE HOME OF TENNIS CONTEST

A. ACCEPTANCE OF TERMS AND CONDITIONS

- These terms and conditions ("*Terms And Conditions*") govern the conduct of the contest namely, "The Home of Tennis" ("*Contest*") which is conducted by Culver Max Entertainment Private Limited and/or its affiliates ("*CME*" and /or the "*Company*") on the second screen , namely, 'Sony Liv' ("Platform (s)").
- 2. You acknowledge and agree that the following terms and conditions constitute a legally binding agreement (hereinafter the "<u>Agreement</u>") between you (and CME and/or its affiliates. - **3.** CME and/or its affiliates shall not be responsible for any technical disruption and/or failure/ server problems and/ or any other difficulties of such nature, due to which the User is unable to submit the Entry on the Platform and/or participate in the Contest.
