

Terms and Conditions for “Maharashtrachi Hasyajatra Talent Hunt” Contest

The following terms and conditions (“**T&Cs**”/ “**Terms and Conditions**”) shall be applicable to contest being conducted by Culver Max Entertainment Private Limited (formerly known as Sony Pictures Networks India Private Limited), (“**Company**” or “**CMEPL**”), relating to its series “Maharashtrachi Hasyajatra” (“**Show**”) on its channel “**Sony Marathi**” (“**Channel**”) which shall function in a manner as specified in this T&C (“**Contest**”) The Contest will be available on the Company’s over-the-top platform ‘Sony Liv’ (“**Platform**”) which shall function in a manner as specified in Specific T&C’s at end of this T&C. (“**Contest**”)

The T&Cs shall be in two parts (a) Basic T&Cs for the Contest and (b) Specific T&Cs for each Contest. Participation in the Contest shall be considered to be acceptance of these T&Cs and terms and conditions available on the Sony LIV App.

In the event the Participant is a Minor, it is strictly clarified that these T&Cs will be read and accepted only by the Legal Guardian (as defined herein below) of the Participants and such acceptance shall be binding on the Legal Guardian along with the Participants through their respective Legal Guardian. All terms and conditions of these T&Cs that are applicable on the Participants shall be directly applicable on the Legal Guardian and it shall be the sole responsibility of the Legal Guardian to ensure such terms and conditions are duly complied with by the Legal Guardian as well as the Participants. The Legal Guardian has read and are aware of the guidelines and any amendments thereof issued by the National Commission for Protection of Child Rights regarding participation of minors in the Contest and/or the Show and are further aware and agree to comply with all applicable laws and regulations with respect to child rights, protection, and other related matters.

Basic T&Cs:

Following are the terms that shall be applicable to the Contest:

1. The Contest is open only to Indian citizens, residing in India, irrespective of their caste, race, ethnicity, colour, sex, religion, sexual orientation, gender identity, family status, disability, medical or genetic condition. Citizens and/or residents of countries other than India are not eligible to participate.
2. The Participants must be either (i) minors having attained the age of 10 (ten) years but not having attained the age of 18 (eighteen) years (herein after referred to as “**Minors**”) or (ii) adults having attained the age of 18 (eighteen) years to participate in the Contest as on the date of the Contest. (All persons fulfilling conditions mentioned in section 1 & 2 shall be hereinafter referred to as “*Participants*”)
3. In the event the Participant is a Minor, in order for the Participant to participate in the Content, it is a compulsion that the Legal Guardian has agreed to the T&Cs and consented to the Participant participating in the Contest. Therefore, we strongly recommend each Legal Guardian to please read the T&Cs carefully prior to the Participant taking part in the Contest to ensure that you understand and agree for and on behalf of such Participant with the terms and conditions of the Contest. As a Legal Guardian, you agree that with the Participant participating in the Contest made available on the Sony LIV App, you (representing the Participant) unconditionally agree to be bound by these T&Cs and shall ensure that the T&Cs are complied with as stated herein. The participation under the Contest does not require purchase of any of the products/ services offered by CMEPL. The Legal Guardian hereby represents that the Participant is not under any exclusive contracts with any other third party/ agency or is not under any kind of disqualification under law to enter into an agreement with CMEPL or its affiliates, as the case may be. For the purposes of this T&C, the term “**Legal Guardian**” shall mean the natural parent of the Participant being his or her biological Father or Mother and shall include persons who take the legal responsibilities of the child as parents on account of adoption or as foster parents. In either case, the relationship shall have to be established by way of proper documentation and CEMPL shall have the sole discretion to decide about allowing such Participants. Legal Guardian shall include such guardian as appointed by a District Court under the relevant provisions of the Guardians and Wards Act, 1890. Any other claim for Guardianship shall have to be established by way of proper documentation and CMEPL shall have the sole discretion to decide about allowing such Participants. For avoidance of doubt, the Parent and/or Legal Guardian shall be an adult citizen of India who is residing in India.
4. The Contest shall be open for participation as per the timelines specified in the T&Cs for Contest.
5. Employees, agents and promoters (including their immediate family members) of CMEPL and any of their divisions, affiliates and subsidiaries, and others associated with the Contest in any manner, acting as Legal Guardians to the Participants and any Participants who are related to any employees, agents and promoters (including their immediate family members) of CMEPL and any of their divisions, affiliates and subsidiaries, and others associated with the Contest in any manner, are not eligible to participate in the Contest.
6. The Contest terms and conditions shall be mentioned on the Platform and/or on the official website of the Channel and the social media handles of the Platform and/or the Channel. The Participants and/or the Legal Guardians, as the case may be, agree that by participating in the Contest, the

Participants and the Legal Guardians shall be bound by the terms and conditions provided on the Platform.

7. The Participants and/or the Legal Guardians, as the case may be, shall be required to provide basic Personal Data about them and the Minors, as the case may be, including but not limited to name, address, phone number, social media profile or any other details as may be required by CMEPL for the purpose of the Contest, in order to participate in the Contest. The Personal Data provided by the Participants in the course of the Contest to CMEPL will only be used for CMEPL's internal purposes and to send Participants promotional information in the future pertaining to the Platform/CMEPL. The Participant and/or the Legal Guardians, as the case may be, hereby consents to receiving such promotional information in the future. In the event the Participant wishes not to receive such future communications, the Participant and/or the Legal Guardians, as the case may be, can opt-out of the same by writing to CMEPL on the same email ID from which he/she receives such promotional information.
8. The specific requirements for the Contest shall be outlined in the Specific T&Cs of the Contest.
9. For the Contest, each Participant must submit their complete entry in order to qualify as an entrant in the Contest ("**Entries**") through Specific Mode of Participation specified in Specific T&C's stated in the Specific T&C.
10. The manner, day and the basis of choosing the winner (defined below) shall be specified in the T&Cs of the Contest.
11. The announcement about the Winners and the Prize(s) (defined below) shall be as per the T&Cs of the Contest.
12. Method and time of prize distribution: CMEPL shall inform the Winners via email or phone number provided by the Participants and/or the Legal Guardians, as the case may be, at the time of entering the Contest or any other mode as mentioned under the Specific T&Cs. CMEPL may require Winners to provide valid photo identity documents including but not limited to passport and ration card prior to handing over the Prize(s). CMEPL may or may not announce the Winners via the Platform.
13. The distribution time and mode of distribution of the Prize(s) shall be at the sole discretion of CMEPL.
14. The Participant can win only once in this Contest. Any subsequent wins of the Participant (if declared) will be automatically void.
15. Participants should ensure the accuracy of the information provided by them and/or the Legal Guardians, as the case may be, at the time of entering the Contest.
16. If applicable, CMEPL shall make a maximum of 2 (two) attempts each attempt being within 1 (one) hour of each other, to contact the Winners via the email id provided by the Participants and/or the Legal Guardians, as the case may be. CMEPL shall not be held liable despite CMEPL's best efforts, in the event the provided mobile numbers/email Id is unreachable/not replied due to the following reasons including but not limited to: 1) Email ID or phone number provided is incorrect. 2) Email ID belongs to a person other than the Participant and/or the Legal Guardians, as the case may be 3) Mobile number answered but individual answering refuses to acknowledge CMEPL, the Contest and/or any relation thereto. 4) Any other reason the Email ID or any other contact details provided by which Participant cannot be contacted.
17. The Prize(s), when the same are in form of some tangible goods or materials or vouchers, shall be sent by post and/or courier to the Winners as per the address specified by them at the time of registering for the Contest. CMEPL shall not be responsible if any Prize(s) is damaged in the course of delivery through post and/or courier.

If someone pretends to be an officer from Sony and demands monies or any other form of identification from you, please do not entertain such request. In the event of any such profanity or abusive comments posted on foregoing pages, such Participants shall be disqualified forthwith and CMEPL reserves its rights, in addition to removing such post, to take a legal action against such participant and/or user.
20. Participants and/or the Legal Guardians, as the case may be, agree no clarifications on the Contest shall be entertained by CMEPL.
21. 25. In exercise of the powers conferred by applicable laws, CMEPL shall treat the Personal Data and/or documents as sensitive and confidential and such Personal Data and/or documents has to be now dealt with as per the provisions specified in the applicable laws.
26. For the purposes of the Contest, CMEPL may contract with the service providers to perform functions or services on its behalf. Such service provider may have limited access to the Participant(s) Personal Data needed to perform their functions, but shall be restricted from using such Personal Data for purposes other than providing services to CMEPL solely in connection with the Contest. CMEPL shall ensure, on reasonable efforts basis, that its service providers that have limited access to Personal Data provided by the Participant(s) and/or the Legal Guardians, as the case may be, to provide the services or perform their function for CMEPL, are subject to the same level of privacy protection as is required by the applicable laws. The Participant(s) and/or the Legal Guardians, as the case may be, hereby agreed that they shall not file any claim against CMEPL for sharing for such Personal Data. Please refer to Platform's Privacy Policy that governs the use of your Personal Data.
27. CMEPL shall deal with any Personal Data, if any, that it receives from CMEPL or otherwise collects, holds, uses and processes in the following manner: a) CMEPL may also disclose Personal Data, if any, to governmental agencies and regulators (e.g., tax authorities), social organizations (e.g., the social security administration), human resources benefits providers (e.g., health insurers), external advisors (e.g., lawyers, accountants, and auditors), courts and other tribunals, and government authorities, to the extent required or permitted by applicable legal obligations upon prior written approval from CMEPL. b) The level of data protection using technical, managerial, operational and physical security control measures by CMEPL shall be such as to be in compliance with all applicable laws. c) The term "**Personal Data**" shall mean and include the name and contact information (home address, telephone and fax numbers and email address), valid identity proof such as passport number, driver's license number, permanent account numbers, social security numbers or other details pertaining to the identity of the Participants and shall include sensitive personal information.
28. By choosing to participate in the Contest, the Participants and/or the Legal Guardians, as the case may be, hereby specifically agrees to receiving updates with respect to the Contest, from CMEPL, on the email ID & phone number shared. In addition to these Terms and Conditions, the Participant(s) and/or the Legal Guardians, as the case may be, at all times shall be subject to the terms and conditions of Instagram, as may be applicable. CMEPL shall not, in any manner, be responsible to any action taken by Instagram with respect to the post made by the Participant and the Participant and/or the Legal Guardians, as the case may be, hereby agrees to not make any claims against CMEPL with respect to the same. Any technical or other issues with respect to the Participant's and/or the Legal Guardians, as the case may be, Instagram account, page and/or operation or functioning of the same shall be taken up by the Participant and/or the Legal Guardians, as the case may be, directly with Instagram, without involving CMEPL in any manner.

29. Participants and/or the Legal Guardians, as the case may be, confirm that the comments, answers and/or entries uploaded by them or any part thereof do not infringe upon the statutory rights, common law rights, intellectual property rights including copyrights in literary, dramatic, musical or motion picture rights, patent rights or the trademark or trade names of any person, firm, corporation, association or entity whatsoever. Neither the comments nor any part thereof violate the statutory rights of, or the right of privacy, or constitute a libel or slander against any person, firm, corporation, association or entity whatsoever, or violate any other rights not herein specifically enumerated. No comments or any part thereof shall be defamatory or contribute contempt of court or breach of contract, or breach of any provision of statute, nor hurt the sentiments of religious groups. In the event of any infringement and/or any unlawful usage of any Personal Data including pictures provided by the Participants and/or the Legal Guardians, as the case may be, CMEPL shall not be held liable on any account whatsoever.
30. CMEPL including its divisions, affiliates and subsidiaries, and their respective agents and representatives, employees shall not be responsible for any loss of Entries for any reason whatsoever including, due to any technical problems for Entries received after the deadline as a consequence of computer service delays, interruptions, electronic failures or overloads, or for lost, misdirected or misplaced Entries or any lost, late or misdirected computer transmission or network, electronic failures of any kind or any failure to receive entries owing to transmission failures or due to any technical reasons..
